Subject: Annual Escalation factor for ARR computation and computation of indexed SOR by Major Port Trusts under Tariff Policy, 2018.

Sir,

As per the clauses 2.3, 2.8 and 2.9 of the Tariff Policy, 2018, the Authority is required to announce the indexation factor considering the Wholesale Price Index (WPI) occurring between 1 January 2020 and 1 January of the relevant year i.e. 1 January 2021 so as to enable the Major Port Trusts to draw the indexed SOR to be applicable during the year 2021-22.

2.1. The WPI occurring between the relevant dates was ascertained from the Ministry of Commerce and Industry, Government of India. Considering 100% of variation in WPI occurring between 1 January 2020 and 1 January 2021, the Authority has approved an Indexation factor of 0.55% for computation of indexed ARR as per Clause 2.3 of the Tariff Guidelines, 2018 for the year 2021-22 and also for automatic indexation of SOR by Major Port Trusts subject to relevant Clause prescribed in the SOR flowing from Clause 3.2 of the Tariff Guidelines, 2018. The indexed SOR shall be effective from 1 May 2021 and shall be valid till 30 April 2022.

3. The Major Port Trusts may, therefore, index their SOR by applying applicable indexation factor of 0.55% for the year 2021-22 effective from 01 May 2021 subject to Clause 3.2 of the Tariff Guidelines, 2018. The indexed SOR shall be effective from 1 May 2021 and shall be valid till 30 April 2022.

4. This issues with the approval of Competent Authority.

Subject: Annual Escalation factor to the extent of 60% of the variation in the Wholesale Price Index (WPI) for indexation of SOR and 100% of the variation in the Wholesale Price Index (WPI) for indexation of Performance Linked tariff under the Stevedoring and Shore handling Guidelines, 2016.

Sir,

As per the Clauses 2.10. and Clause 3.5.5 of the Stevedoring and Shore handling Guidelines, 2016, 60% variation in WPI is to be considered for indexation of upfront tariff and the indexation of royalty in absolute terms respectively. Clause 7.1 of the said Guidelines stipulates that the operator can apply indexation in tariff at 100% of WPI variation instead of 60% variation in WPI on written confirmation by Major Port Trusts to the operator that it has achieved notified Performance Standards for each cargo.

2. The WPI occurring between the relevant dates was ascertained from the Ministry of Commerce and Industry, Government of India. 100% variation in WPI occurring between 1 January 2020 and 1 January 2021 works out to 0.55% and 60% variation in WPI occurring between 1 January 2020 and 1 January 2021 works out to 0.33%.

3. The annual indexation factor approved by the Authority effective from 1 April 2021 to 31 March 2022 under the Stevedoring and Shore handling Guidelines of 2016 is as follows:

- (i). Annual indexation of 0.33% at 60% of WPI for indexation of SOR as per Clause 2.10 and indexation of royalty in absolute terms as per Clause 3.5.5 of the Guidelines for Determination of Upfront Tariff for Stevedoring and Shore Handling Operations authorized by Major Port Trusts under Section 42 (3) of the Major Port Trusts Act 1963; and
- (ii). Annual indexation factor of 0.55% for indexation at 100% of WPI (instead of 0.33% given above) to arrive at Performance Linked Tariff as per Clause 7.1 of the Guidelines for Determination of Upfront Tariff for


