The percentage rate quoted shall be inclusive of labour, materials, tool and plants, transportation, machinery etc. complete. GST will be reimbursed as applicable. Payment will be made after satisfactory completion of work and applicable taxes will be recovered from the bill. The NMPT reserves the right to accept or reject quotation without assigning reasons thereof.

The amount put to quotation is bare minimum cost of work. If the quotationer quotes less than or equal to amount put to quotation then his / their quotation will be considered as the bid with Nil charges. Such quotation will be treated as Non-responsive and will not be considered for evaluation. In case if, two or more bidders quote same minimum charges/minimum % and tie occurs, the successful bidder would be finalized by drawing the lottery with prior intimation to the bidder whose bids are tied, in presence of eligible bidders.

The Contractor shall enclose **“Bid Security (EMD) Declaration Form”** duly signed along with the quotation. The offer submitted should be open for acceptance for a period of 90 days from the date of opening the same.
