**TRADE CIRCULAR**

Sub: Mandatory use PPE equipments inside Port

-----  
In terms of Dock Workers (Safety, health and Welfare) Act, 1990, use of Personal Protective Equipments (PPE) by the dock workers is mandatory. However, it has been noted that many Port workers entering the Wharf are not using the mandatory PPE. Hence, as decided in the 113<sup>th</sup> Port Safety Committee Meeting, all dock workers intending to enter and work at Wharf must compulsorily wear PPE (Safety Helmet, Safety Shoes and Reflective Jacket) failing which they may not be allowed to enter the docks.

The dock workers are also hereby advised to note that they must continue to wear the PPE during their entire stay at Wharf. All concerned are hereby advised to ensure that the above is strictly adhered to and also to advice the members/workers attached to their respective section for strict compliance of the same.

CISF is being advised to ensure strict compliance of the same with effect from 01.01.2022.
