# TERMS AND CONDITIONS FOR THE POST OF PASS INSPECTOR ON CONTRACT BASIS

### I) Qualification/Eligibility:

- a) In case of Ex-Servicemen, retired Lieutenant/Captain rank officers and in Police category, retired Sub Inspector/Inspector/Asst. Commissioner of Police is considered for the job. The documents for the service rendered in Army/Police Department are to be submitted.
- b) Age shall not exceed 65 years during the currency of engagement.
- c) Engagement to the post of Pass Inspector shall be subject to his/her being medically fit for the duties to be performed in the said post. Therefore, the candidate selected for the post of Pass Inspector on contract basis will, at the first instance, have to report to the Chief Medical Officer of the NMPA Hospital to undergo necessary medical examinations, prior to joining for duty.
- II) Security Bond: He/she shall execute a Security Bond in the prescribed proforma to the effect that he/she shall serve in the New Mangalore Port Authority as a Pass Inspector on contract basis for a period of 03 years with effect from the date mentioned in the letter of appointment.
- III) WORKING HOURS: Pass Inspectors engaged on contract basis shall work in Pass Section of the Port in 3 shifts of 8 hours each on rotation basis with one Weekly holiday after 6 days of work. If he/she is not allowed to avail any of the Weekly holiday due to some exigencies of Port's service, he/she will be permitted to avail Compensatory Holiday in lieu of the duty performed by him/her on the Weekly Holiday within 03 months from the date of the weekly

holiday. He/she will report to the Deputy Conservator, New Mangalore Port Authority, and will work in accordance with the instructions and directions of the Deputy Conservator, New Mangalore Port Authority.

- **IV) LEAVE ENTITLEMENT:** He/she is entitled for 15 days Casual leave per year at the rate of 1.25 day/month. The non-availed portion of casual leave can be carried forward to the following year. However, the casual leave cannot be accumulated for more than 20 days.
- V) GROSS FIXED SALARY: Rs.27,000/month with 5 % increment every year for the 2<sup>nd</sup> year and 3<sup>rd</sup> year of contract.
- VI) ACCOMMODATION: Type II or Type III quarters will be provided subject to availability but Electricity and water charges etc. as applicable will have to be paid by the individual occupying the quarters.
- VII) Tenure of the Engagement: The tenure of contract period will be for 03 years from the date of engagement mentioned in the letter of appointment.
- VIII) If a Inspector avails himself/herself of any leave other than the casual leave of his/her entitlement or refuses to work on any day, deduction of a sum proportionate to the period of absence will be made from his/her monthly emoluments by calculating on the basis of his/her monthly emoluments divided by 30.
- IX) The contract engagement shall not confirm on him/her any right to lay claim to permanent absorption/appointment in the Port service against any vacant post whatsoever.

- X) The Port reserves the right to cancel the contract engagement if need arises, without further notice and/or without assigning any reason.
- XI) Settlement of Disputes: In the event of any dispute arising out of this contract, the interpretation and decision of the Chairman, New Mangalore Port Authority will be final and binding.

If the candidate is amenable to the terms and conditions set out above, he/she will be required to execute a security bond in the format given herewith for the period of engagement as a **Pass Inspector** on Contract basis and join for duty on the stipulated date mentioned in the letter of appointment.
