TRADE CIRCULAR

Sub: Annual Escalation factor to the extent of 60% of the variation in the wholesale Price Index (WPI) for indexation of Royalty under the Stevedoring and Shore handling Policy, 2016-Reg.

As per the Clause 3(v) of the Stevedoring and Shore Handling Policy for Major Ports 2016, the Port shall fix per metric tonne Royalty rate to be collected from the Stevedoring and Shore handling Agents. Further, Clause 3.5.5(b) stipulates that the Royalty assessed by the Port in absolute terms is subject to indexation to an extent of 60% of the variation in the Wholesale Price Index occurring between 1st January and 31st December of the relevant year.

As per the IPA Letter No. IPA/MSD/WPI/Tariff/2022 dtd.22.03.2022 the Annual Indexation at 60% of WPI is 6.46%.

Accordingly, the present Royalty at the rate of Rs. 6.09 per tonne is indexed by 6.46% i.e.**Rs.6.48** per tonne w.e.f.**01.05.2022.**

All Stevedoring and Shore Handling Agents are requested to note and to pay the Royalty at the indexed rate mentioned above.
