**TRADE NOTICE**

**Sub : Maintaining of Record of workers deployed by the stevedores – Reg.**

This is to draw your kind attention to the deliberations and conclusions arrived therein the 110<sup>th</sup> Port Safety committee Meeting held on 11<sup>th</sup> November 2020, which was chaired by the Chairman, NMPT and was attended by the members of the Port Safety committee and the officers of the Inspectorate of Dock Safety, New Mangalore.

During the meeting it was decided that as per the Dock Worker's Safety Health and Welfare Regulations 1990, necessary recordings of the dock workers including casual and private workers engaged by the stevedores should be undertaken. In this back drop of the decisions concluded in the interest towards the adherence of the safety standards, the following instructions shall be complied by the stevedores:

- Record the details such as Name, Adhaar No. of the workers deployed by the stevedores per shift per vessel and submit the duly signed copy by the supervisor to the Traffic control room in charge in each shift.
- Register shall be maintained for the above purpose and the same to be furnished to the enforcement authorities on demand.
- The Stevedores to explore possibilities to install hand held electronic readers/gadgets to capture the required details of the dock workers engaged by the stevedores in each shift per each vessel.

Therefore, all the Stevedores operating in the port are hereby directed to abide by the above decisions. Any deviations from the above advisory shall be viewed seriously and action as per the Stevedoring Regulations shall be initiated.
