Sub: Grant of Permission/Fixation of Port Charges for handling
Non-Exim Cargo at NMPT Railway Marshaling Yard-Reg.
Ref: Resolution No.178/2020-21 of Board of Trustees.

The Board of Trustees, New Mangalore Port Trust, vide Resolution No. 178/2020-21 of the Board meeting held on 29.03.2021, has accorded approval to grant permission to all the port users for handling Non-Exim Cargo at NMPT Railway Marshalling Yard, subject to conditions that they will take all the precautionary measures for preventing the spillage of cargo at the yard and the roads and also be responsible for dust suppression and that the expenditure for such arrangements shall be borne by them.

The charges for usage of NMPT railway marshalling yard for handling all type of non-Exim cargo shall be at Rs. 29.68 per metric tonne the period 01.04.2021 to 31.03.2022 subject to revision w.e.f. 01.04.2022.

All the port users are therefore requested to note and avail the above facility at NMPT Railway Marshalling Yard.
