**TRADE CIRCULAR**

Sub : Submission of ' Safety Compliance Undertaking' by stevedores \_Reg.

\*\*\*\*\*

In view of enhancing safety in the port, the Stevedoring and Shore handling Agents shall submit an undertaking to the Port , confirming due compliance to the Statutory Provisions during the Cargo handling Operations thereto the provisions of the Dock Workers (Safety, Health and Welfare) Act 1986 and Dock Workers (Safety , Health and Welfare )Regulations 1990 and any other applicable provisions notified by the Central government from time to time . Also, the stevedores shall ascertain safe handling of Cargo onboard / on shore , including transportation / stacking / delivery of cargo . The SOPs and any other instructions from the Port shall be adhered to . The Loose gears owned by the stevedores shall be of good quality and the required tests of the gears shall be carried out . All the workers shall be provided with PPEs appropriate to their work and the cargo handled. The stevedoring and Shore handling agents shall be solely responsible for any accident and damage resulting from the operations performed by them and they shall indemnify the Port against any third party claims arising out of any operation performed by the stevedore.

Hence , all the stevedoring and Shore handling operating in the Port , shall submit the undertaking in prescribed format before commencement of Cargo handling operation for each vessel to the Safety Officer in the prescribed format enclosed.
