VTS MANAGER (MASTER MARINER) ON CONTRACT BASIS.

Qualification and Age:

- i) Must hold a certificate of competency as Master of Foreign-going Ship, issued by the Ministry of Ports, Shipping and waterways, Govt. of India or an equivalent qualification recognized by the Ministry of Ports, Shipping and waterways, Govt. of India with GMDSS.
- ii) One year post qualification experience as Master/Chief Officer of a foreign going ship.
- iii) Age: Not more than 60 years as on the date of Appointment.

TERMS AND CONDITIONS

The Terms and Conditions for recruitment of VTS Manager (Master Mariner) on contract basis exclusively for deployment in the VTS or any other jobs as assigned by the Dy. Conservator or his representatives are as follows:

- 1. Working Hours: The VTS Manager (Master Mariner) on contract basis are to work in VTS on 08 hours shift of 0600 –1400 hrs, 1400 –2200 hrs and 2200-0600 hours.
- 2. Monthly remuneration: The consolidated pay for a VTS Manager (Master Mariner) on contract basis is ₹1,50,000/- if not provided with Port quarters. However, if Port quarters is provided, necessary Licence fee, water charges and electricity etc. as applicable will be levied.

3. SECURITY BOND (applicable to initial appointees only)

He/she shall execute a Security Bond (in the pro-forma enclosed) to the effect that he/she shall serve in the New Mangalore Port Trust as a VTS Manager (Master Mariner) on contract basis for a period of 02 years with effect from the date mentioned in the letter of appointment.



4. LEAVE ENTITLEMENT

He/she is entitled for 20 days Casual Leave per year at the rate of 05 days Casual Leave for every 03 completed months of service. The non-availed portion of casual leave can be carried forward to the following year. However, the casual leave cannot be accumulated for more than 20 days.

- 5. Guest House accommodation will be provided free of cost before allotment of the quarters.

- 8. Either side can terminate the contract by giving one month's notice (not applicable to initial appointees).
- 9.If a VTS Manager (Master Mariner) avails himself/herself of any leave other than the casual leave of his/her entitlement or refuses to work on any day, deduction of a sum proportionate to the period of absence will be made from his/her monthly emoluments by calculating on the basis of his/her monthly emoluments divided by 30.
- 10. In-house medical treatment shall be provided at the Port Trust Hospital free of cost to the VTS Manager (Master Mariner), his/her spouse and children.
- 11. The contract engagement shall not confirm on him/her any right to lay claim to permanent absorption/appointment in the Port service against any vacant post whatsoever.
- 12. The Port reserves the right to cancel the contract engagement if need arises, without further notice and/or without assigning any reason.
- 13. In the event of any dispute arising out of this contract, the interpretation and decision of the Chairman, New Mangalore Port Trust will be final and binding.
