

Terms and Conditions :-

1. The rate quoted for the above foam compound are for Delivery F.O.R, NMPT Store, Panambur, Mangalore - 575010.
2. Supply shall be made within 60 days from the date of supply order.
3. The rate quoted shall be firm and valid for 120 days
4. The rate quoted shall be inclusive of all taxes, levies and duties etc, as applicable exclusive of GST. GST if any shall be quoted separately.

5. Applicable statutory taxes if any will be deducted at source while making the payment.
6. The supplied items shall meet the latest relevant Indian Standard (IS4989:2018) and shall have a guarantee of 12 months from the date of supply. The Guarantee Certificate shall accompany with the supplies.
7. Packing & Forwarding and Freight charges including Transit Insurance shall be shown separately at Sl. No.4 of B.O.Q.
8. Security Deposit: 3% of the basic value of the material (Sl.No.1 of BOQ) will be deducted from the bill and retained as Security Deposit. The same shall be released after satisfactory completion of guarantee period.
9. The material should be inspected by M/s. Indian Register of Shipping/M/s. ABS Industrial Verification(India) Pvt. Ltd./ M/s. DNV / M/s. Bureau Veritas(I) Pvt. Ltd./ Lloyd Inspection Agency Pvt. Ltd., (Third party Inspection Agencies) before dispatch and Third Party inspection report shall be sent along with dispatch document including manufacturers test certificate. The TPI charges shall be shown separately at Sl.No.2 of B.O.Q.
10. No advance payment will be made. Full payment shall be made deducting 3% as Security Deposit within 15 days from the date of supply in good condition and receipt of bill along with dispatch document including manufacturers test certificate& TPI Certificate.
11. Liquidated damages for delay in Supply:
In the event of delay in supply beyond the stipulated time, the liquidated damages @ 0.5% per week subject to maximum of 10% of basic value of the order shall be leviable.
