

Payment will be made after satisfactory completion of work and applicable taxes will be recovered from the bill.

The EMD shall be paid through RTGS/NEFT to the following bank details in favour of the FA&CAO, NMPA. The copy of receipt shall be enclosed along with the quotation. The benefit of exemption of EMD to all Micro and Small Enterprises (MSE) shall be allowed. The proof of being MSE registered with District Industries Center (DIC) shall be enclosed. The quotation without copy of receipt of RTGS/NEFT/Certificate will not be entertained.
