Sub: "Helicopter services for Tourist arriving at Cruise Terminal of New Mangalore Port Authority"—Competitive Quotation Requested -Reg.

The successful bidder shall be allowed to operate a Helicopter to ferry the tourist arriving at NMPA Cruise Terminal vide various passenger ships in and around Mangalore.

In view of the above, to finalize an agency for the present tourist cruise season (up to May 2023), **sealed competitive quotations are invited** for "Helicopter services for Tourist arriving at Cruise Terminal of NMPA" as per **Price Bid** enclosed on Terms and conditions as detailed below.

Terms & conditions for casual hiring of vehicles

- 1. The rates quoted shall be over and above the applicable charges payable for parking the Helicopter inside the wharf area of NMPA per day. The bidder shall have to pay a minimum parking fee of Rs 3000/- per day excluding GST (a) for parking the Helicopter. GST as applicable will be paid extra. The Contractor shall quote the rates as per the Price Bid enclosed. The Heli services shall be availed based on the cruise vessel schedule and as and when required by the Port.
- 2. The helicopter that will be operated shall be well maintained and in good operating condition. The helicopter shall have valid registration certificate, Tax Paid certificate, Insurance Covering all risks of Pilot and passengers traveling in the helicopter, fitness certificate or any other statutory/legal certificates required to operate the chopper inside the Port and in around Mangalore etc.



- 3. The Copter must have valid permit and should have minimum seating capacity of 5 passengers excluding pilot.
- 4. The period of operation shall be for period from November 2022 to May2023 and the helicopter shall be called for services as and when required by the Port on a daily basis for which charges as quoted over and above the daily parking charges in the price bid format shall be paid to the Port after sailing of each vessel. The contractor shall be intimated well in advance on the arrival of the Cruise ship, who may deploy the copter on the day of arrival of the ship for ferrying the tourist. Necessary charges for the same shall be collected by the contractor.
- 5. The Contractor shall pay the fixed parking fee of Rs 3000/- excluding GST plus the additional charges quoted by the bidder with applicable GST @ (b) by 7th day after the sail of the each Cruise vessel by means of RTGS/NEFT in favour of FA&CAO, NMPA. All damages, if any levied during the operations, shall also have to be paid along with the parking plus the quoted charges. Traffic department shall certify the certificates/invoice in this regard.
- 6. Performance Security: The successful bidder shall deposit Rs 6000/- to NMPA Account as performance security within 10 days from the award of contract, which shall be returned without interest after the completion of the contract.
- 7. The contractor shall be ready to operate the copter even on Sundays if required based on the arrival of the cruise ship.

- 9. The competent authority of New Mangalore Port Authority reserves the right to accept the quotation wholly or partially, and split the quotation or to reject any or all offers in part or full without assigning the reason thereof.
- 10. In the event of continued unsatisfactory performance or non-compliance with any of the provisions of this contract, NMPA reserves the right to cancel the contract and forfeit the Security Deposit by giving 30 days notice.
- 11. Further, NMPA reserves the right to terminate/pre-close the contract at its convenience, without assigning reasons to the contractor by giving a notice period of 30 days. The contractor shall not have right of any claim on NMPA on account of such termination.
- 12. Any damages to the Helicopter provided to the Port or any other vehicle or persons due to any accident or due to any other reasons during the period of contract will be at contractor's risk and cost. The Port Authority shall not be responsible for the same in any manner.
- 13. Income tax as applicable will be deducted at source.
- 14. The trip sheet in the prescribed format shall be maintained duly indicating the timings and hours run for each trip. The original trip sheets shall be enclosed to the bill for verification by Traffic department.
- 15. Copy of PAN Card and the Certificate of registration of payment of GST. The bill shall be addressed / handed over to Traffic Manager, Panambur,
- 16. The contractor shall be responsible to comply with all the requirements of various labour, commercial law/rules, all statutory requirements necessary for the contract, any acts/rules applicable to this contract.
- 17. Contractor shall be responsible to pay all taxes, charges and duties prescribed for operation of the Helicopter within the state of Karnataka.

- 18. The Pilot shall wear a uniform neatly and shall maintain cordial relationship with the passengers and departmental officers/officials.
- 19. The bid shall be evaluated based on the rates quoted at (b) of the price Bid excluding GST. The bidder who has quoted highest rate shall be awarded the contract and shall be issued necessary permission to operate the Helicopter services.
- 20. The quoted rate shall remain firm and fixed during the entire period of contract.

 NMPA will award the contract to the bidder who has offered the highest price.
- 21. The supply order itself binds as agreement for the subject hiring.
- 22. The necessary Port entry passes will be issued by NMPA for Pilots and Helicopter if required as per prevailing rules.
- 26. The competitive quotation in complete shape and as required above enclosed in a sealed cover superscribed as **Quotation for** "Helicopter Services for Tourist arriving at Cruise Terminal of **New Mangalore Port Authority**" should reach to this office on or before 07.11.2022 at 15:30hrs.
- 27. The sealed competitive quotation will be opened on 07.11.2022 at 16:00 hrs in the Chamber of Executive Engineer (Mechanical)II, NMPA in the presence of such tenderer who may wish to be present.
