## Terms & Conditions:

1. The Calibration shall be carried out on quarterly basis and contract period will be for **1 year**.



- 2. The Tenderer should submit copy of Authorized Certificate issued by the OEM or any authority for calibration of Gas Detector and GST registration certificate along with the tender.
- The amount quoted shall be firm and inclusive of all expenses including TA/DA & other incidental expenses of your Service Engineer, Calibration Kit & suitable recommended gas for testing etc. Applicable GST shall be shown separately. The GST will be paid extra as per the documentary evidence.
- 4. Your Service Engineer shall give his expert advice and guidance to Port's Operators for proper maintenance and efficient working of the Gas Detectors. The Competent Personnel / Service Engineer shall be deployed for carrying out the calibration work.
- 5. Please note that no advance payment will be made. But full payment will be made within 15 days after each quarterly calibration to the entire satisfaction of the Engineer-in-Charge.
- 6. Necessary Calibration Report should be furnished duly signed by the authorized engineer for making payment after each quarterly calibration.
- 7. Applicable statutory taxes if any will be deducted at source while making the payment.
- 8. The Tenderer may visit the work site and get acquainted himself with the site conditions, nature of work involved before quoting, taking prior appointment with the undersigned. Any assistance in this regard will be provided by the Department.
- 9. No tools, plant, labour, equipment, transport, etc. required for the work will be supplied by the Department and the Contractor has to make his own arrangements.
- 10. Free Port entry passes to the Contractor and his workmen and vehicle during the period of work will be issued to carry out the work as per rules.
- 11. The contractor has to deploy skilled and competent personnel's for carrying out the work and contractor shall be responsible for making good of all the damages done during the work.
- 12. The Tenderer shall be responsible for taking precautionary measures for the safety of the workmen working under him and the responsibility arising due to anymishap during the execution of work, payment of any compensation etc., lies entirely on the part of the Contractor. Safety Items required while working are to be provided by the Contractor.
- 13. The acceptance of the Tender rests with the competent authority of NMPA who does not bind himself to accept the lowest Tender and reserves to himself the authority to reject any or all the Tenders received without assigning any reason.
