Ref: This Office enquiry letter No. 20/114/2023-24/EE(M)III-TS(OTM) dated 10/04/2023.

The Terms & Conditions No. 21. Bid Security / Earnest Money Deposit (EMD), is added to the enquiry letter dated 10/04/2023 cited at Ref. above for the subject work and bidders are requested to note the above & furnish the required Bid Security / Earnest Money Deposit (EMD) alongwith the quotation for the subject work.

21. Bid Security / Earnest Money Deposit (EMD)

I) a) The quotation shall accompany the Bid Security/EMD of Rs.23,350/- (Rupees Twenty Three Thousand Three Hundred Fifty only) inclusive of 18% GST in the form of Insurance Surety Bonds or Account Payee Demand Draft or Fixed Deposit Receipt or Banker's Cheque or Bank Guarantee from any of the Commercial Banks.

Or

b) Micro and Small Enterprises (MSE) registered with District Industries Centre (DIC) or Khadi and Village Industries commission or Khadi & Industries Board (KVIB) or Coir Board or National Small Industries Corporation (NSIC) or Directorate of Handicrafts and Handlooms or Udyog Aadhar memorandum or any other body specified by Ministry of MSME shall be exempted of EMD on producing self-attested supporting certificates.

Failure in submission of EMD will render the Bidders disqualified, except in the case as per Terms & Conditions No. 21(I) (b) above.

II) In the event of forfeiting the EMD, GST is applicable.


III) In the event of Tenderer withdrawing his tender before the expiry of tender validity period of 30 days from the due date of submission of offer, the tender shall be cancelled and EMD shall be forfeited.

- IV) The Earnest Money Deposit of unsuccessful Tenderers shall be returned without interest as early as possible on award of Contract to the successful Tenderer. The Earnest Money Deposit of the successful Tenderer shall be refunded (without interest) only after completion of work.
- V) The bidder shall be disqualified/terminated duly forfeiting EMD (if applicable) and may be debarred for a period of three (3) years from participating for tenders at New Mangalore Port Authority duly informing the MSME authorities if applicable, if
- a) The Bidder withdraws the Bid after Bid opening during the period of Bid Validity;
- b) The successful Bidder fails within the specified time limit to:
- (i) Sign the Agreement
 - (ii) Fail to commence the work on the specified date as per LOA/Work order
 - (iii) If the bid is varied or modified in a manner not acceptable to the Employer during the validity or extended validity period duly agreed by the Bidder
 - (iv) If any information or representation submitted by Bidder is found to be false or incorrect
 - (v) Any effort by the Bidder to influence the Employer on bid evaluation, bid comparison or contract award decision.

The Tenderers / Bidders are requested to sign & seal on all the pages of NMPA's enquiry letter dated 10/04/2023 cited at Ref. above and this Corrigendum letter and furnish along with their quotation for the subject work as token of acceptance of Terms & Conditions and scope of supply & work.

All other Terms & Conditions of enquiry letter dated 10/04/2023 cited at Ref. above, shall remain unaltered.
