TERMS & CONDITIONS:

- 1. The rate quoted for the items shall be firm and exclusive of applicable Taxes and F.O.R destination basis. Please note that NMPA is not issuing any concessional C or D forms. Quotation shall be submitted along with GST Registration.
- 2. Applicable GST will be paid as extra on submission of documentary evidence.
- 3. The contract period shall be for a period of **two years** on **quarterly basis** from the issue of Work Order.
- 4. Please note that no advance payment will be made. But payment will be made on monthly basis within 15 days from the date of receipt of bill after the satisfactory completion of service, attending the complaints etc. and certified by the Engineer-in-charge.
- 5. The Tenderers should quote their rates in figures as well as in words the amount tendered by them. The amount per each item should be worked out and requisite total should be given. All rates shall be quoted in proper form in the tender schedule enclosed. **The rates quoted should be valid for 90 days**.
- 6. The Tenderer shall have experience in Supply & Installation/Maintenance of Fire Alarm, Smoke Detection System, CCTV, Biometric Access Control System. Documentary evidence/supporting documents such as Work order/Work Completion Certificate shall be submitted along with the offer without which the bid will not be considered for evaluation and liable for rejection.
- 7. The Tenderer may visit the work site and get acquainted himself with the site conditions, nature of work involved before tendering. Any assistance, in this regard will be provided by the department under prior appointment and the undersigned may be contacted for the purpose.
- 8. The Tenderer shall be responsible for making good of all the damages done during the work and has to employ skilled & competent workers for carrying out the work.
- 9. The Tenderer shall be responsible for taking precautionary measures for the safety of the workman working under them and the responsibility arising due to any mishap during the execution of work, the payment of any compensation etc., lies entirely on the part of the Contractor.
- 10. The evaluation shall be done on the basis of total lowest value (L1) quoted. The GST element if any will not be considered for evaluation.

- 11. The acceptance of the tender will rest with competent authority of NMPA who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all of the tenders received without assigning any reason.
- 12. The required spares for replacement of wornout/damaged items and Fire Suppression Gas etc. will be supplied departmentally to the contractor to carryout the Repair /Replacement.
- 13.No tools, plant, Labour, equipment, transport, etc., required for the work will be supplied departmentally and contractor has to make his own arrangements.

14. Scope of work

1 MAINTENANCE

1.1 BREAKDOWN MAINTENANCE

This is to be carried out in the event of malfunction, which prevent the operation of the equipment. Work to be carried out during the service coverage time as per the AMC Contract. Breakdown Maintenance includes fault finding, repair or replacement of defective parts and functional checking.

1.2 PREVENTIVE CHECKUP

This consists of measures regarded by Manufacturer as necessary to maintain the equipment in proper operating condition. Preventive checking shall be carried out between Monday to Saturday during working hours (9AM to 5PM) planned in advance with customer representative.

2. SPARES AND MATERIALS

The defective parts diagnosed during maintenance can either be repaired or replaced by new at Contractor cost.

3. RESPONSE /TURN AROUND TIME

During the break down of the system at any time, the contractor required to set right/rectify the problem within 24 Hrs of the complaint.

4. TOOLS/INSTRUMENTS

The contractor has to provide necessary tools and instruments to their service Engineer for the purpose of servicing the equipment covered by the contract.

5. AMC EXCLUDES THE FOLLOWING :-

Defects arising out of improper handling, misuse, damage, accidents, Sabotages, lightning's wrong applications, electrical disturbances / faults in USER'S Electric supply system (such as absence of Earthling or presence of Earth to Neutral Voltage), any modification carried out by User on System or software.

6. MOCK DRILL AND REPORT:-

As per the guidelines of NCIIPL & IB, the quarterly mock drill of all alarm systems provided at data center need to be carried out and the report shall be submitted to the Concerned Engineer-in-Charge of NMPA.

15.If the Tenderer after award of work/contract fail to execute the work in the specified allotted period, then the Tenderer shall be debarred for a period of three (3) years from participating for tenders at New Mangalore Port Authority.
