- 1. The time allowed for completion of work is **30 Days** from the date of issue of work order.
- 2. The rate quoted shall be firm and applicable GST shall be mentioned separately.
- 3. Technical specifications of Multimedia Projector to be supplied is shown in the Annexure.
- 4. The evaluation shall be done on the basis of total lowest value (L1) quoted. The GST element if any will not be considered for evaluation.
- 5. The bidder should submit copy of OEM / Authorization Certificate, GST Registration Certificate along with the quotation. The quotation without Authorization Certificate & GST registration certificate shall be liable for rejection.

- 6. Please note that no advance payment will be made. Payment will be made within 15 days after satisfactory completion of the subject work to the entire satisfaction of the officer -in-Charge.
- 7. The Guarantee of two years to be provided for the projector from the date of handing over after the installation.
- 8. The Rates quoted should be valid for 90 days.
- 9. No tools, plant, labour, equipment, transport etc. required for the work will be supplied by the Department and the Contractor has to make his own arrangements.
- The bidder shall be responsible for making good of all the damages done during the work if any, and has to employ skilled & competent workers for carrying out the work.
- 11. The bidder shall be responsible for taking precautionary measures for the safety of the workmen working under him and the responsibility arising due to any mishap during the execution of work, payment of any compensation etc., lies entirely on the part of the Contractor. Safety Items required while working are to be provided by the Contractor.
- 12. The Bidder shall indemnify New Mangalore Port Authority against all losses and claims.
- 13. Liquidated Damage : If the supplier fails in delivery of Multimedia Projector as per the terms of the supply order, the NMPA shall be entitled to charge penalty/liquidated damages @ Rs. 0.5 % per week or part thereof, subject to a maximum of 10% of the order value.
