TERMS & CONDITIONS:

- 1. The rate quoted for the items shall be firm and F.O.R destination basis. Please note that NMPT is not issuing any concessional **C or D forms**.
- 2. Applicable GST will be paid as extra as per actual.
- 3. The time allowed for rewinding & replacement of 40HP Motor is **10 days** from the date of issue of work order.
- 4. Please note that no advance payment will be made. But payment will be made within 15 days after satisfactory completion of work.
- 5. Income Tax will be effected for recovery at the rates as from the gross amount of the work contract bills as per the relevant provisions of the I.T. Act.
- 6. The Tenderer may visit the work site and get acquainted himself with the site conditions, nature of work involved before tendering. Any assistance, in this regard will be provided by the department under prior appointment and the undersigned may be contacted for the purpose.
- 7. The above rates are for carrying out the Rewinding of Motor, replacement of bearings at your work site including Dismantling, Transportation, Reassembling and Re-installation at site. The rate shall be after the deduction of scrap value of copper & Bearings.
- 8. The Tenderers should quote their rates in figures as well as in words the amount tendered by them. The amount per each item should be worked out and requisite total should be given. All rates shall be quoted in proper form in the tender schedule enclosed. The rates quoted should be valid for **30 days**.
- 9. The work may be taken up immediately after handing over the same by the Department.
- 10. The Items to be supplied should conform to the specifications and standards of IS & warranty period of 6 months.
- 11. The acceptance of the tender will rest with competent authority of NMPT who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all of the tenders received without assigning any reason.
