# Sub: Extending License to Service Providers on a composite basis for a period of 5 years for providing cargo handling services to handle dry bulk cargos at NMPA anchorage – Reg

With a view to facilitating the nomination and handling of deep draft dry bulk cargo vessels including the Cape vessels at Port, the Board of New Mangalore Port Authority has accorded approval to adopt a licensing model on a composite basis for a period of 5 years for providing cargo handling service for dry bulk cargo at NMPA anchorage.

The Terms of Reference (TOR) for issuance of the License is attached as Annexure-I and various charges applicable/ payable (ad-hoc rates, rates prescribed other than those available in the Scale of Rates of NMPA) is attached as Annexure-II.

Accordingly, all interested service providers may apply to the office of the Traffic Manager through the email address provided below along with requisite documents prescribed in the TOR to obtain the License, which shall be issued on a **First-Come-First-Served basis**, subject to confirmation of the annexures mentioned in the TOR by the respective departments of NMPA & the application being in order :

#### **Terms of Reference (TOR)**

#### 1. Services:

----

- i. The license shall be issued on a composite basis for a period of 5 years to the licensee for providing the cargo handling service at the anchorage.
- NMPA reserves the right to issue the number of licenses considering the safety, availability of Civil and Marine infrastructure in the port and capacity of navigational infrastructures.
- iii. The License shall be issued on a **First-Come-First-Served basis** subject to submission of all the documents in complete shape fulfilling the requirements.

iv. The services to be provided by the Licensee are outlined below:

#### v. General Terms & Conditions for issuance of License

#### a. Requirements for nautical infrastructure:

i. The Floating Crane, Transhipper, Barges shall not be more than **20 years old** from the date of commissioning. Relevant certificates shall be produced to confirm the same.

- ii. Floating Crane, Transhipper, Barges shall possess necessary valid vessel-related certificates & insurance coverage, including wreck removal & pollution prevention to operate at NMPA Port limits i.e. within 12 nautical miles. Inland Vessels (IV) shall not be permitted due to their restriction of voyage up to 5 nautical miles in the fair season as per DG Shipping Order No: 08 of 2018 (F.No:33-NT(07)/2017) dated:04/09/2018. However, IV vessels with exemptions to proceed beyond 5 nautical miles, obtained from DG Shipping or DG Shipping approved classification societies or by Karnataka Maritime Board may be permitted to operate within the Port Limit.
- iii. The Floating Crane, Transhipper, Barges shall be owned or taken on lease or taken on hire by the licensee during the entire tenure of license. In case of hired/leasehold equipment, the Licensee shall produce copies of relevant agreements.
- **iv.** The Floating Crane, Transhipper, Barges shall be free from any kind of liabilities of tax, duties, cess, levies, penalties and any other duties imposed by any authorities in India and abroad as the case may be and also take all approvals/clearances/permission from any statutory bodies or outside agencies to deploy within the port limits of NMPA for operation.
- v. The Licensee shall comply with requirements under India Port Act, Port Entry Rules 2012, MPA Act, Merchant Shipping Act or any other provision under regulation or Act as per GOI.
- vi. The Licensee shall maintain and comply with all necessary approvals, authorizations, Surveys, Certifications, statutory provisions necessary pursuant to Applicable Law for the performance of its obligations during the tenure of license and ensure to possess valid Certification, Insurance along with other vessel related documents at all times during the tenure of License and produce whenever required by NMPA.
- **vii.** The licensee shall submit the Draft Survey Report and SOF at the earliest, also to determine the quantity of cargo loaded/unloaded, to determine the applicable charges to be remitted to the port, etc.
- viii. The Licensee shall be solely responsible for safe anchorage stay, safe navigation, pollution prevention, adequate manning, safe conduct, etc during the complete tenure of the license, The Licensee shall observe the weather conditions periodically and advise their vessels and crafts under their control

to take safety measures as per situational requirement. The licensee shall be solely responsible for any loss of life, accident or incident due to the negligence of their vessels, crafts and personnel and NMPA will not be responsible in any manner whatsoever.

**ix.** The berth day output of 15,000 MTs is envisaged per day for barge loading so as to meet the berth day output of transhipper at the anchorage. The licensee may plan infrastructure like floating storage and shore cranes to meet the performance parameters.

#### b. Requirements for Shore Cranes:

- **i.** The cranes shall not be more than **10 years old** from the date of commissioning. Relevant certificates shall be produced to justify the same.
- ii. The prospective Licensee shall have to produce a certificate from OEM Charter Engineer, Appropriate authority as 'Fit for Work' and have at least
  3 years residual life, relevant certificate from DG FASLI and other statutory bodies.
- iii. Crane shall be owned or taken on lease or taken on hire by the licensee during the entire tenure of the license. In case of hired/leasehold equipment, the Licensee shall produce copies of relevant agreements.
- **iv.** Crane shall be free from any kind of liabilities on tax, duties, cess, levies, penalties and any other duties imposed by any authorities in India and abroad as the case may be. Also, take all approvals/clearances/permission from any statutory bodies or outside agencies to deploy crane for operation at NMPA.
- **v.** The licensee shall maintain a valid insurance policy for the crane indemnifying the port from compensation under any circumstances during mishap.

#### c. General :

The Licensee shall comply with the requirements of all the Acts, Laws, Statues, Bylaws, Rules and Regulations for the purpose of fulfilling all the obligations of the Contract which shall include but not limited to the Major Port Trust's Act, 1963, the Indian Contract Act, the Dock Workers (Safety, Health & Welfare) Regulations, 1987, Motor Vehicles Act, Minimum Wages Act, 1948, Contract Labour (Regulation and Abolition) Act, 1970, Industrial Dispute Act, 1947, Shops and Commercial Establishment Act, Factory Act, 1948, Workmen's Compensation Act, 1923, ESI Act,1948, Payment of Wages Act, 1963, Bonus Act, Employees Provident Funds & Misc. Provisions Act, 1952, The Marine Insurance Act 1963 etc. and such other applicable Central / State Acts from time to time and take such steps as may be deemed necessary in this regard.

#### d. Location of Transfer Point: -

- i. Within the area at Port Anchorage Transshipment co-ordinates shall be as follows:

  - 2) 13<sup>0</sup>00.0'N 074<sup>0</sup>40.5'E
  - 3) 12<sup>0</sup>59.0'N 074<sup>0</sup>39.45'E
  - 4) 12<sup>0</sup>59.0'N 074<sup>0</sup>40.5'E,
- ii. Mother vessel anchorage: 12°59.7'N 074°41.5'E
- iii. The Licensee should have suitable floating Yokohama fenders of sufficient size and numbers for double banking of vessels at the anchorage.

#### **TERMS AND CONDITIONS:**

- During the monsoon/shutdown period, the barges will not be accommodated inside the port and shall be shifted to other locations outside the port on the licensee's account & responsibility. Suitable berths for Floating crane and Transhipper shall be allocated by the Traffic Department subject to availability.
- 2) The idling charges for the Shore Cranes deployed by the licensee to handle iron ore and other dry bulk cargo for barge loading/unloading for anchorage operation shall be as per Land SOR. In respect of Port Cranes, Cargo handling Charges shall be as per SOR.
- 3) Documents related to Marine crafts like Transhipper, Floating Crane, Barges and other crafts if any shall be examined by the Marine Dept, and documents related to shore cranes shall be examined by the Mechanical Engineering Dept. and to be placed to the Traffic Department for issuance of license.
- 4) The Traffic Dept. will issue the license with the approval of the Competent Authority and collect day-to-day recording of cargo data and shall ensure collection of CRC i.e. Wharfage, Cargo handling charges, License fee. Marine Dept. shall collect VRC i.e. Port dues, Pilotage, Berth Hire and Anchorage charges as per the procedure in vogue.
- 5) Statement of Facts (SOF) and Draft Survey Report (DSR) shall be considered for calculating cargo handling charges.
