

REQUEST FOR BUDGETARY QUOTATION

1. New Mangalore Port Authority (NMPA) proposes to provide CAAQMS (Continuous Ambient Air Quality Monitoring System) at the New Mangalore port premises as per the requirement of statutory requirement.
2. Thus invites budgetary quotation from the applicants for preparation of cost estimate and to invite tender for supply, installation, testing and commissioning including operation and maintenance of CAAQMS at one location for a period of 5 years.
3. The budgetary quotation shall be submitted by parties who have successfully installed and commissioned the CAAQMS as per CPCB (Central Pollution Control Board) guidelines.
4. The parties submitting the budgetary quotation shall have experience, technical expertise, financial capability and operational experience in installation and commissioning of CAAQMS as per CPCB guidelines.
5. The scope of present proposal is to install and commission the CAAQMS including operation and maintenance for a period of 5 years after successful installation at one location as per the requirement of KSPCB following the guidelines and any other statutory requirement.
6. The budgetary format is placed at Annexure A and requested interested applicants to submit their budgetary quotation in the prescribed format only.
7. The lowest budget quotation will be considered for cost estimate for inviting tenders for supply, installation, testing and commissioning including operation and maintenance of CAAQMS at one location for a period of 5 years.
