Terms and conditions:

- 5. The materials to be supplied from the latest manufactured batch, supply should be effected within 30 days from the date of issue of Purchase Order. The materials will have to be supplied on `Door delivery basis to the undersigned duly insured at your cost.

- 6. The materials shall be dispatched to the undersigned, duly covering the transit insurance. Any damage to the items during transportation shall be to suppliers account. If the supplied items are rejected due to any error/ defects in the technical specification, supplier has to make his own arrangements at his cost to lift the rejected materials and to replace the same immediately without any delay.
- 7. The materials to be supplied should conform to the specification as per the Technical Data Sheet attached along with the quotation (Annexure).
- 8. The material supplied shall be guaranteed for a minimum period of 12 months from the date of supply for any manufacturing / performing defect and the guarantee certificate shall accompany the supplies. Any defects/damage found in the supplied materials, shall be replaced immediately at free of cost by the supplier.
- 9. Payment will be made within 15 days after the completion of supply along with warrantee Certificate and receipt of invoice.
- 10. Statutory taxes as applicable will be deducted while releasing payment.
- 11. 
