Terms and conditions

1. The job must be thoroughly inspected prior to quoting.
2. Rate to be quoted excluding GST. GST as applicable would be paid extra.
3. All works must be carried out to the entire satisfaction of Engineer-in-charge of the tug. After completion of works Non Destructive testing (NDT) must be carried out to ensure the water tightness.
4. Rate quoted for repair works must include charges for material, travelling, accommodation, boarding, local conveyance to port, labour, workshop charges, cost of consumables, transportation/logistic charges of tools etc and must be in realistic manner based on present market rate.
5. The required tools and plant including special tools if any, labour, materials, consumables etc. should be arranged by the firm.

6. All measures and aspects to be adapted to protect environment to comply with ISM/ ISO standards. Working personnel should make use of proper PPE and follow safety regulations. Hot work if any has to be carried out with due approval/hot work permit from port fire service.
7. All released materials must be handed over to the Engineer-in-charge of the vessel.
8. Full payment will be made within 15 days after satisfactory completion of work and submission of bill. Income tax as applicable would be deducted from the bill, at the prevailing rates
9. Taxes applicable and the transportation charges if any are to be clearly mentioned in the quotation.
10. Six months guarantee to be provided for the work. Any defect during guarantee period to be attended free of cost by the firm.
11. Quotation with counter condition by the firm shall be liable for rejection
12. Any damage to the Port properties during repairs will be at Contractor's account.
13. Quotation in complete shape in a sealed cover subscribed as "Quotation for repair work of damaged bulwark with frames on Port Tug Iswari" should reach the undersigned on or before 11 Jan 24 by 1445 hrs and will be opened on the same day at 1500hrs.
