TRADE NOTICE

Sub: Movement of Cargo vehicles during the Construction phase of
Modernization of K.K Gate – Reg.

NMPA has taken up the work of modernization of KK Gate to cater the increase in volume of cargo and have a seamless movement of cargo through KK Gate. During the construction phase of subject work, the existing gate will remain closed w.e.f. 14.03.2024 till the completion of work. The alternative arrangement for vehicular traffic of KK Gate will be as follows;

1. During the construction work commencing from 14.03.2024 until the completion of work, only the outward movement of Trucks laden with cargo from JSW MPTCL will be permitted through the temporary gate (ODC Gate).
2. All empty trucks for loading coal at JSW MCTPL will only be permitted from Mallya Gate w.e.f 14.03.2023.
3. JSW Mangalore Coal Terminal Pvt. Ltd. shall deploy suitable number of man power at the temporary gate (ODC gate) to ensure that vehicle traffic is managed hassle free and does not lead to any congestion in the roads leading to NMPA Gates.
4. Other cargo vehicle movement is planned as below;
 - a. Through Mallya Gate- IN and OUT movement of Fertilizer, Timber vehicles (both empty and loaded), IN movement of loaded / empty containers, trailers, auctioned cargo if any.

- b. Through SJ Gate- OUT movement of loaded / empty containers, steel coil movement, tankers of IMC, IPWC.
- c. Material movement of MCTPL & APL terminals shall be carried out through Mallya Gate.
5. Any change in Traffic from the gates will be informed to CISF and Port Users.
