Terms & conditions:

The above rates shall be inclusive of the following:-

1. Examining, testing, adjusting and overhauling the said Weighing Scales is to be carried out annually. However, if required the request calls to be attended for any complaint immediately without any extra cost.
2. As per the statutory requirement, Verification and calibration by the Inspector of Weight and Measure Department as per the related Act, to be done once in a year. Stamping and other charges claimed by the Weight and Measure Department as per actual which will be paid extra on production of receipt /vouchers issued by the concerned department.
The Conveyance charges of the Legal Metrology officials for stamping work will be paid extra **at actual on producing of receipt.**
3. The said weighing scales to be painted with anticorrosive paint of approved shade once in a year, to the complete satisfaction of the department.
4. Any spare parts like knife edges, bearings, wrought iron shackles, wrought iron links, wrought iron steel legs and suspension rods, ribbon rubbers, rubber bolts, nuts and screws are to be replaced as and when required without extra cost.
5. Any damage to the departmental properties if caused by you during the course of repairs/maintenance will be recovered from your bill.
6. The Servicing Charges will be made paid within 20 days after satisfactorily completion of annual **servicing once in a year.**
7. The rate quoted shall be inclusive of taxes which may be indicated separately without "C or D" form since this office cannot issue C or D form for concessional CST.
8. All Disputes are subject to Mangalore Jurisdiction only.
