By letter dtd. 10.04.2024, the Police Inspector, Traffic North Police Station, Bykampady, Mangalore has informed that there will be gathering of large number of people during the visit of Hon'ble Prime Minister of India on 14.04.2024. In order to avoid inconvenience to the people and facilitate smooth traffic flow, safety and security of Hon'ble Prime Minister of India, the movement of heavy vehicles carrying all types of cargo including empty truck trailers/tankers will not be allowed from 08.00 pm of 13.04.2024 to 08.00 pm of 14.04.2024. He has also requested not to park any vehicle on NH 66.

Accordingly all Port Users are hereby requested to note that movement of heavy vehicles will not be permitted through New Mangalore Port during the above period also to ensure that their vehicles are not parked on NH 66.
