- 2. The contractors shall thoroughly inspect the fire tender and access the details of all works to be carried out before submitting the quotation by contacting the **AEE (Mechl.), Automobile Sub Division**, NMPA or undersigned. Also the agency can check the vehicle at their respective workshop thoroughly to avoid any additional works during/after the execution works. No additional payments will be made for any extra work carried out which is not quoted by the contractor.
- **3.** The rate quoted should be valid for at least **90 days** from the due date of submission of offer.
- **4.** No advance payment will be made but 90% of Payment with 100% GST will be made within 15 days after successful completion of the job and submitting of bill induplicate to the undersigned. GST shall be shown separately.
- **5.** Balance 10% payment will be withheld till the completion of Guarantee period of 6 months and the same shall be release without interest after completion of Guarantee period.
- 6. The work shall be completed within 15 days from the date of issue of Work order. The work will be carried out to the entire satisfaction of Engineer In Charge, NMPA i.e **Executive Engineer (Mechl.)I.** Any damage to the Fire tender during the execution of works will be on the Contractors account.
- 7. Statutory taxes as applicable will be deducted while releasing payment.
- **8.** The entire work shall have a guarantee of 6 months from the date of successful completion of the work.
