# 1-प्रस्तावना /INTRODUCTION

This note is submitted to seek the approval of the Competent Authority to re invite
the Tender for appointment of "Operator" to carry out the work of "Operation,
Management and Maintenance of renovated Truck Parking Terminal, situated
opposite to Customs House building"

# <u>2-पृष्ठभूमि/BACKGROUND</u>

- The department vide NIT No CE/SE(C-II)/EST/TRKPAK-OPT/2024-25 dated 24.04.2024 had invited tender for appointing an Operator to carry out the work of "Operation, Management and Maintenance of renovated Truck Parking Terminal, situated opposite to Customs House building"
- In response to the said notification 4 Bids were received. The Tender committee in its meeting held on 31.07.2024 found that, amongst the 4 Bids , the Bid submitted by only one Bidder is Technically responsive. In this regard, the Tender committee recommended to the competent Authority that, "since the Tender is floated for the subject work for the first time and that after the Technical Evaluation converging to single qualified bid, it is recommended to open the Price Bid of the single qualified Bidder after approval of the Competent Authority."
- In this regard, the subject issue was discussed in the Review meeting held on 28.08.2024. Based on the decision taken in the said Review meeting, the

department, vide Pg. No 44 of the subject work's Hard File bearing No CE/SE(C-II)/EST/TRKPAK-OPT/2024-25; submitted the Tender Committee proceeding dated 31.07.2024 for the approval of the Competent Authority , with a recommendation to discharge the Tender . The department's proposal to discharge the Tender was approved by the Competent Authority vide Pg. No 52 of the said Hard file.

# <u>2-प्रस्ताव/PROPOSAL</u>

- As the Truck Parking Terminal is ready for commissioning and appointment of an Operator to carryout its Operation has become a very critical event, it is proposed/Instructed to immediately re-invite Tenders for appointment of an Operator to carry out the work of "Operation, Management and Maintenance of renovated Truck Parking Terminal, situated opposite to Customs House building"
- In this regard, the Tender document invited by the department vide NIT dated 24.04.2024 has been slightly modified to encourage more number of prospective Bidders to participate in the Tendering process. The comparative statement depicting the revisions carried out is tabulated below:-

# 1- INTRODUCTION

- The Chief Engineer (C) under Noting 5, has requested to clarify, whether the proposal is for re invitation of tender on same terms and conditions or fresh proposal?
- · In this regard following is submitted:-
  - The first Tender was invited by the Port for the subject work vide NIT dated 24.04.2024 and Tender No CE/SE(C-II)/EST/TRKPAK-OPT/2024-25. It had been discharged with the approval of the Competent Authority, due to Technical reasons.
  - The subject proposal is the second attempt to appoint the "Operator" through e-Tender process for carrying out the subject work, with slightly revised terms and conditions.
  - During the first attempt, Port had received Offers from four Bidders. But when the Technical Bids received from the 4 Bidders were evaluated as per the Tender conditions stipulated in the Tender document CE/SE(C-II)/EST/TRKPAK-OPT/2024-25, the Bid submitted by Only one Bidders was found to be technically responsive and had resulted in a single Offer.
  - Hence, the Minimum Eligibility Criteria, stipulated in the current draft Tender document
     (CE/SE(C-II)/EST/CHTPT-OPT/2024-25) has been slightly modified to expect more
     number of competitive Bids. The comparative statement depicting the revisions between earlier
     Tender document and the current draft Tender document has been already submitted under SI.No
     2 of Noting 1 above.
- Subsequently, discussion on the issue regarding payment of "Monthly Power Consumption Charges" in respect of power consumed to operate the FASTag based Parking Fee Collection System, Lighting of Operator's Cabins/Office, was held with Deputy Chairperson in the presence of AEM(Gr-I) and SE(Elec). The point of discussion was whether the "Monthly Power Consumption Charges" needs to borne by the "FASTag Service Provider" OR the "Truck Terminal Operator"? In this regard, the Terms and conditions stipulated in the FASTag Tender was reviewed. It was observed that, under SI No 7 of the Pre-Bid clarification to the Tender document (FASTag's Tender document ), issued by the Port, Port has clarified that Power supply will be provided on chargeable basis to the Service Provider for Testing and Commissioning of the facilities. Hence, it was opined that during the Operation period, the Service provider is not liable for payment of "Power Consumption Charges" Moreover, during the Operation period as the role of Service Provider is limited only upto AMC of the equipment, it would be difficult to enforce such condition on the Service Provider. Accordingly in the current draft Tender document, it has been stipulated that, the Operator is liable to bear the monthly Power consumption charges based on Power consumed to operate the FASTag based Parking Fee Collection system, Operator's Cabin & Office Lighting etc, as per the prevailing Tariff of the Port Authority. The rates quoted by the Bidder shall be inclusive of said monthly Power consumption charges and the Bidder shall examine the Port Tariff for Electricity from the Port Authority before bidding. The said Clause has been incorporated under Section -I, Clause -3(ii)&(iii), Section-III, Clause -16 and foot Note (ii)&(iii) of the specimen price bid.
- Further based on the observation of AEM(Gr-I) under Noting 2 above, in the current draft Tender document it has also been stipulated that, the Port has proposed to expand CHTPT, on its eastern side. This additional facility will be developed on 5,340 Sq.m (approx) land area, which will further accommodate about 80 trucks. However, as the proposal of expanding CHTPT is in inception stage, initially only the existing CHTPT (12000 Sqm) will be handed over to the Operator for its Operation, Management and Maintenance. The additional 5340 Sqm will be handed over for its Operation, Management and Maintenance after completion of expansion works. The said Clause has been incorporated under Section -I, Clause -1, (ii) Section-II, Clause 2.1, Section-III, Clause -10.
