Sub: Revision of Royalty collected from Stevedoring and Shore Handling Agents – Reg.

The Board of New Mangalore Port Authority, in its meeting No.7 of 2024-25 held on 26-12-2024 resolved to increase Royalty per ton levied from Stevedoring and Shore Handling Agents by 3% i.e Rs.7.16/- per ton (subject to Annual indexation) under the provision of clause 9(1) of the New Mangalore Port Trust (Licensing of Stevedoring and Shore Handling) Regulation 2019.

Accordingly the revised Royalty for Stevedoring and Shore Handling Agents activities shall be Rs.7.16/- per ton (subject to Annual indexation) which may be applicable w.e.f 15-01-2025 to the Cargo of the vessels berthed on or after the above said date.
