Port hospital has been taken over by the concessionaire M/s Srinivasa Port Hospital (P) Ltd. from 04.11.2024 as per the concession agreement. For administrative convenience NMPA was running the hospital till 30<sup>th</sup> June 2025. From 1<sup>st</sup> July 2025 the concessionaire has taken over the functioning of the existing port hospital by himself. One (01) Port doctor will be available in the existing NMPA hospital from 08:00 am to 10:00 pm for addressing any issues related to the patient including treatment and issuing referral letter to referral hospital (including referral consultant).

**Following is the process to obtain referral letter for treatment at hospital other than PPP.**

1. Send an E-mail to [receptioncounter150@gmail.com](mailto:receptioncounter150@gmail.com) with the hospital name and department.
2. Referral letter will be generated and sent through E-mail to patient and to referral Hospital within reasonable time.
3. Pensioners can also use pension portal ([nmpt.in:4443/login-register.jsp](http://nmpt.in:4443/login-register.jsp)) for generating referral letter.

5. Helpdesk (contact numbers 0824- 2887574 / 8050306888) will be available on 24X7 basis at the existing old hospital manned by nurse with computer having access to pension portal for assistance.
