(ii) Minimum One year of clinical experience in a Hospital after the completion of Internship of one year.

(iii) Medical Officers retired (below 65 years) from Government / Public / Private Sectors can also apply

Desirable: Post Graduate Medical Degree / PG Diploma from a Recognized University / AFIH Course

TERMS AND CONDITIONS

1. **SECURITY BOND**

The candidate, on his / her appointment as Medical Officer on Contract basis, shall execute a security bond (in the specimen attached herewith) to the effect that he / she shall serve in the NMPA as a Medical Officer on contract basis for a period of Two years from the date of his / her joining as a Medical Officer on Contract basis and extendable for one more year on the basis of the service rendered.

2. **CONSOLIDATED SALARY**

The monthly consolidated salary payable to the Medical Officers engaged on contract basis at this Port shall be at Rs. 60.000/- per month, if no accommodation or conveyance is provided by the Port. The revision in remuneration may be considered once a year based on Consumer price index.

3. **TENURE OF ENGAGEMENT**

The tenure of engagement shall be for a period of two years, which may be extended for one more year depending on requirements.

4. **WORKING TIMINGS**

He / she shall report to the Chief Medical Officer, New Mangalore Port Authority, and shall work in accordance with the instructions and directions of the Chief Medical Officer. The working hours will be decided by the Chief Medical Officer.

He / she is to leave the place of duty only after the reliever Doctor reports and takes over the charge from him /her.

5. **LEAVE FACILITIES**

He / she shall be permitted to avail 15 days Casual leave during the period of his / her engagement on pro-rata basis @ 1.25 days casual leave for each completed calendar month of contract service. No provision exists for encashment of the non-availed portion of any kind of leave.

He / she shall be permitted to avail the following three National Holidays in a Calendar year i.e. –

1. Republic Day – 26th January
2. Independence Day – 15th August
3. Mahathma Gandhi Jayanthi – 2nd October

He / She avail any leave other than casual leave of his / her entitlement or refuses to work on any day, deduction of a sum proportionate to the period of absence will be made from his / her monthly emoluments by calculating on the basis of his / her monthly emoluments.

6. **MEDICAL FACILITIES**

He / she shall be entitled to free medical treatment in the New Mangalore Port Authority Hospital for self and family to the extent of the facilities available at in-house.

7. **TA / DA FOR TOUR & TRAVEL**

As and when required to be deputed on official tour for the purpose of work, he / she will be entitled to draw TA / DA as applicable to the category of the post held by him / her with prior approval of the Chairman on each occasion, obtainable through the Chief Medical Officer, Port Authority Hospital. No TA / DA will be

paid either for attending the interview or for joining for duty in response to this offer.

8. **OTHER SERVICE BENEFITS**

For the purpose of attributability for the injuries sustained by him / her during his / her course of duty, the Medical Officer on contract basis will be treated as an employee of New Mangalore Port Authority Board only during his / her duty hours.

9. **TERMINATION OF CONTRACT**

His / her engagement as Medical Officer on contract basis can be terminated by either side, by giving one month's prior notice during the current period of the contract.

10. **CLAIM FOR REGULARIZATION OF THE CONTRACT**

The contract engagement shall not confer on him / her any right to lay claim to permanent absorption in the port service against any post whatsoever.

11. **ACCOMMODATION**

The candidates selected for engagement will be permitted to occupy the Port Quarters if he / she opts for the same. The class of accommodation that would be allotted to him / her shall commensurate with the post held by him / her subject to availability of vacant quarters. However, proportionate deductions towards quarters Rent , Electricity and water Charges will be made from the monthly consolidated salary payable to him / her.

12. **SETTLEMENT OF DISPUTES**

In the event of any dispute arising out of this contract, the interpretation and decision of the Chairman, New Mangalore Port Authority will be final and binding.

The Port reserves the right to cancel the Contract Engagement if need arises, without further notice and / or without assigning any reason.

If the candidate is amenable to the Terms and Conditions set out above, he / she will be required to execute a Security Bond in the prescribed format given herewith for the period of engagement as a Medical Officer on Long Term Contract Basis and shall join for duty on the stipulated date. On the other hand, if he / she is not in a position to join for duty by the said date, he / she must send necessary communications duly intimating the date by which he / she will be able to join for duty as a Medical Officer Long Term on Contract Basis at this Port Hospital. If he / she fail to comply with both the options, this offer will stand cancelled.

In addition to the above, the Contract Medical Officer must take note of the fact that his / her engagement to the post of Medical Officer on Long Term Contract basis shall be subjected to his being medically fit for the duties to be performed in the said post. Therefore, the candidates selected for the engagement as Medical Officers on Long Term Contract Basis will, at the first instance, have to report to the Chief Medical Officer of the Port Hospital to undergo necessary examinations prior to joining for duty as Medical Officers on Long Term Contract basis.
