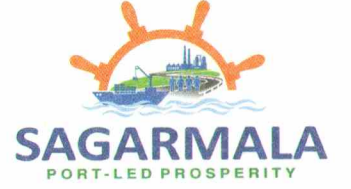

Sub : Extension of free period from the existing 7 free days (excluding Customs and Port holiday) to 15 days (including Customs and Port Holiday) for import cargo.

In view of the request from the Port Users and considering the adverse impact of COVID-19 pandemic on Exim Trade, the Board of Trustees have approved the extension of free days for import bulk/ break bulk cargo (except containers) from 7 (seven) days (excluding Customs Holidays and Port's non-working days) to 15 (fifteen) days (including Customs Holidays and Port's non-working days) up to 31-03-2021.

The above free days shall be applicable to the import bulk/ break bulk cargo (except containers) of the vessels calling at the Port on or after 01-01-2021 up to 31-03-2021.
