**TRADE CIRCULAR**

Sub:Annual Escalation factor to the extent of 60% of the variation in the wholesale Price Index (WPI) for indexation of SOR and 100% of the variation in the wholesale Price index (WPI) for indexation of Performance linked tariff under the Stevedoring and Shore handling Guidelines, 2016.

Ref: Trade Circular no. 53/2/2017/TGA.4 dtd. 07.06.2018

Tariff authority of Major Ports had notified upfront Tariff for Stevedoring and Shore Handling Operations of New Mangalore Port Trust under the Stevedoring and Shore Handling Guidelines of 2016 vide Gazette No: 195 dated 25.05.2018 which is in force w.e.f 26.06.2018. As per Clause no. 7.1 the tariff is entitled to 100% WPI indexation subject to achievement of performance standards.

Vide TAMP letter No. TAMP/12/2009-Misc dtd. 19.03.2021 the notified annual indexation factor of 0.55% for the period 01.04.2021 to 31.03.2022. As the Stevedores have not achieved the performance standards prescribed, the Tariff is indexed @ 60% of the indexation factor notified. Accordingly the upfront Tariff for Stevedoring and Shore Handling Operations of New Mangalore Port Trust circulated vide Trade Circular No. 53/2/2017/TGA.4 dtd. 07.06.2018 is indexed by 0.33% w.e.f 01.04.2021.
