**TRADE NOTICE**

Sub: Implementation of Mobile X-RAY Container Scanner charges at  
Rs.211 per TEU w.e.f 01/05/2021- Reg.

TAMP vide order cited at Ref.1 above has notified the revised rate for Container Scanning charges at Rs. 211 per TEU applicable to all import and export laden container in schedule 4.7 of the existing SOR of NMPT. Further the same was brought to the notice of trade vide trade notice cited under Ref.2.

Also as per the notes (3) of schedule no.4.7, "the tariff prescribed above will be indexed to inflation but only to an extent of 60% of the variation in Wholesale Price Index (WPI) occurring between 1<sup>st</sup> January 2020 and 1<sup>st</sup> January of the relevant year, such automatic adjustment of tariff cap will be made every year to 30<sup>th</sup> April of the following year. The first annual indexation in tariff shall be on 1<sup>st</sup> May 2021". The indexed rate w.e.f 01/05/2021 is Rs. 211.70.

In this regard, it is informed that the Port has received the license to operate the container scanner from Atomic Energy Regulatory Board on 29/04/2021 and has commenced the operation of Container Scanner w.e.f . 01/05/2021.

Accordingly, it has been decided to levy Container Scanning charges at the rate of Rs.211 per TEU w.e.f 01/05/2021 applicable to all import and export laden containers whether it is scanned or not. Further the rate will be revised to Rs.211.70 per TEU as and when the decision is taken to impose indexation.
