Sir/Madam,

A post of Managing Director in the pay scale of Rs.2,00,000– 3,70,000 (pre-revised Rs. 80,000–1,25,000) is proposed to be filled up on deputation basis from eligible and willing officers from Major Port Trusts, Government Ministries / Departments. As per the approved Indian Ports Association Employees' (Recruitment, Seniority and Promotion) Regulation, 2016, the post of Managing Director in IPA is a Class-I post and the method of recruitment is 'By deputation, failing which by transfer, and failing both by direct recruitment'. In case of deputation, the post is to be filled up from amongst the persons from the following grades:

"2 years as Chairman of Major Port Trust or 4 years as Deputy Chairman of Major Port Trust or 20 years in AIS/CS/Group A service, of which 2 years shall be in the Ministry of Ports, Shipping and Waterways at the level of Joint Secretary and above"
