TRADE NOTICE

Sub: Exemption of port Charges for RoPAX/Passenger Ferry Operations –Reg.

The Ministry of Ports, Shipping & Waterways, is constantly working towards promoting the surface water transportation encouraging the newly emerging inland passenger and vehicle movement eco-system of the country. However, due to rising marine fuel prices, the RoPax passenger ferry operations in the country may get impacted.

The Ministry vide letter No. SM-25021/49/2016-SM (Sagarmala) (Part-1)(e321573) dtd 22-07-2022 in exercise of the power conferred by section 71(f) of Major Port Authority Act 2021 has directed the Major Ports to exempt all the berth hiring and vessel related charges being currently levied to the RoPax/Passenger ferries for the next six months with immediate effect.

Accordingly, all the vessel related levied at NMPA will be exempted for RoPax/passenger Ferry operations for a period of six months, from **22-07-2022 till 21-01-2023**.

This Trade notice supersedes the earlier Trade notice No.1/2/NMPT/TM/2022-23/Gen-2 dtd. 02-08-2022.
