SECTION-II

INSTRUCTIONS TO BIDDERS

- 1) NMPA has built the KK Gate Truck Parking Terminal No-1 (KKGTP No-1) to accommodate and streamline the movement of EXIM/Coastal Cargo to in and out of the Port in an efficient and effective manner. The KKGTP No-1 shall have facilities for the users including Revenue generating components within the KKGTP NO-1. The Operator shall have a single point responsibility to manage and operate the KKGTP NO-1 during the Operations Period and he has no right of ownership whatsoever on the Truck parking Terminal given on operation and management basis.
- 2) Sealed quotations are invited by New Mangalore Port Authority, Panambur for the work of “Operation and Management of K K Gate Truck Parking Terminal no-1 (WBM surface), **adjacent to Beach Road** at New Mangalore Port for a period of 3 months”.
- 3) Quotation envelope shall be super scribed with (i) Name of the work, (ii) Quotation No. and (iii) Due date with opening time. The quotation shall be submitted in to Chief Engineer (Civil), Civil Engineering Dept., AO Building, Panambur, Mangalore - 575010 on or before the due date. No quotation received after the scheduled time shall be considered and no request/ communication from the end of any Bidder shall be entertained by NMPT in connection with late submission of Quotation.

- 5) The Bidder shall submit copy of (i) PAN certificate and (ii) Goods & Service Tax registration certificate, and (iii) Income Tax returns filed in the last 3 assessment years ending 31st March 2021 along with his Quotation. **(Annexure-1, 2 & 3)**
- 6) All Bidders are advised to visit the “KK Gate Truck parking Terminal No No-1 before submitting their offers, in order to make themselves fully aware of the site conditions and assess the number of Trucks that would avail the Parking facilities. New Mangalore Port Authority will not be responsible for any cost or expenses incurred by the Bidders in connection with preparation or delivery of the Quotation, including costs and expenses related to visits to the sites.
- 7) In the Price Bid, the Bidders are required to quote their monthly Lump sum License premium Fees in Rupees. The offer shall be submitted in the format shown at **Section-V** of this Quotation document.
- 8) The offers will be evaluated/ calculated by the Authority on the basis of monthly Lump sum License premium Fees offered by the bidders. The work shall be awarded to the Bidder, who quotes the highest monthly lump sum License premium fee.
- 9) The Highest Bidder/Operator will be awarded the work by the Authority to operate and manage the Truck Parking Terminal “KKGTP No-1” by collecting the Parking fees as per the Authority’s Scale of Rates and other allied facility fees from the Truck Operators/Customers availing the respective facilities in the Terminal.
- 10) In return, the Successful Bidder /Operator shall remit the advance Lump sum monthly premium License fee offered by him in the quotation along with the Goods & Service tax at the applicable rate to the Authority.

SECTION-III

GENERAL CONDITIONS OF CONTRACT

- 1. CONTRACT PERIOD:** - Three (3) months from the date of Work order.
- 2. WORK COMMENCEMENT DATE:** - The Truck Parking Terminal shall be commissioned within **Seven (7) days** from the date of Work order; failing which the contract will be terminated and END shall be forfeited. However, in exceptional cases where the Authority is satisfied that the delay is for reasons beyond the control of the Operator, the Operator may grant extension subject to payment of additional monthly premium license fee calculated at 50% of the normal Monthly Premium License Fee for the non operational period.

3. PAYMENT OF MONTHLY LICENSE FEES:

The Operator/Contractor shall pay to the Authority “Advance monthly premium License fees” within seven days prior to the commencement of the corresponding month. Liability to pay such Monthly Premium License fee will commence from the date of Work order/Letter of Acceptance. The payment shall be transferred to the account of the Authority through RTGS/NEFT and the letter from the concerned Bank shall be submitted as a documentary proof of remittance of the Monthly Premium License fee to the Authority within the time stated above. Any delay in payment of amount due to the Port shall entail payment of interest @SBI MCLR plus 2% per annum on the amount outstanding.

- 4.** The fee to be levied and collected in respect of the Truck parked at the terminal is furnished in **Appendix ‘A’ of this document**. The “Operator” shall display the same on Board Measuring 4 feet X 3 feet, near the entrance gate of the Truck Parking Terminal. Under no circumstances, should the Operator demand or collect any extra amount, other than those prescribed. If any such complaints received from users of the Truck parking terminal, the action as deemed fit against the Operator will be taken.

5. The key plan of the KK gate Truck Parking Terminal No-1. is enclosed along with this letter as **Appendix-B.**

6. Miscellaneous conditions:

The Chief Engineer (Civil)/Dy.Chief Engineer (Civil) shall have the right to omit at his discretion one or more items of work when placing the order or during the course of execution, if necessitated. Similarly the Chief Engineer (Civil)/Dy.Chief Engineer (Civil) may alter or substitute some of the items in the interest of work. The rates for such altered/substituted items shall be worked out by the Engineer in charge as per standard CPWD practice and paid. No claim whatsoever will be entertained in the regard and the decision of the Engineer in charge will be final.

7. Applicable Taxes, duties and cess shall be remitted by the Operator/Successful Bidder to the Authority along with the Lump sum monthly License fees as per the prevailing Government orders and statutory norms.

8. The work shall be done to the satisfaction of the Engineer-in-charge or his representatives. The work is to be carried out with due diligence and executed in a workman like manner. The Engineer in charge may cancel the contract at his option at any time without notice for any reason including poor Operation and management. The decision of the Engineer in charge is final and shall be binding on the Contractor/Operator.

9. In case the Operator/Contractor leaves the work incomplete, the Engineer in charge shall have right to have the work completed through any other agency and recover the extra expenditure incurred by the Port in doing so from any money due to the Contractor/Operator.

10. The Contractor/Operator shall conform to and comply with the Regulations and by-laws of the New Mangalore Port Authority Board and of all local authorities, the Factories Act, Indian Electricity Rules, the Government Customs, Police Department, etc. The Contractor/Operator shall conform to rules, regulations etc., concerning injury to workmen, insurance for workmen etc. The Contractor/Operator shall also conform to Rules 1971.

11. The Contractor/Operator shall be responsible for any accident, damage or injury caused to any of his employees or property in course of the work and shall hold the Port Authority blameless in respect thereof and also in respect of any claim made by any persons or any reasons whatsoever.

12. The Contractor/Operator shall be solely responsible for reporting to the Board and the Police Department immediately of any serious or fatal accident

inside the Port Authority's premises to any of his employees/workmen engaged by him or any person involved in an accident as a whole of the work.

- 13.** The work shall be carried out on round the clock basis, without any holiday. The successful Operator shall deploy suitable number of personals to manage and operate the Terminal

14. UNDERTAKING/AGREEMENT

Within 21 days from the ward of work, the successful Bidder shall execute an Undertaking on non judicial stamp pamper of requisite value (Rs 100).

15. REFUND OF EMD/BID SECURITY

The Bid Security of unsuccessful Bidder shall be returned to the respective Bidders on award of Contract to the successful Bidder. No interest shall be payable on the amount of Bid Security in any case.

The Bid Security of the successful Bidder shall be returned within thirty days after successful completion of work as per terms and conditions of contract. No interest shall be payable on the amount of Bid Security/EMD in any case.

16. EXTENSION ON EXPIRY OF CONTRACT PERIOD:

The Contract period shall be for a period of Three (3) months and the contract shall not be renewed automatically on expiry of the said contract period. However, the Authority with the consent of the Operator may extend the Contract for further period, in spells of 3 months each, if the performance of the operator is found to be satisfactory.

In the event of the Authority not extending the contract period at the end of three (3) months period the "Operator" shall not be entitled for any compensation of whatsoever nature from the Authority for the expenses incurred in respect of the development of the said premises of any kind of whatsoever nature.

17. SCOPE OF WORK:

- (a) During the Contract period the Operator shall carry out the daily maintenance of the KKGTP NO-1; which includes Conservancy or Housekeeping and Janitorial services, regular day to day periodical inspections to keep the KKGTP NO-1 fully operational at all times of operation. Further the Operator shall be totally responsible for the maintenance, management and operation of the additional **TEMPORARY/Portable facilities** installed by him, viz Operator's Office building, Canteen building, , Commercial petty shops, First Aid Centre, Tire puncture cum minor repair workshops etc.

- (b) The “Operator” has to maintain the premises and the terminal parking area in clean and hygienic conditions by engaging suitable persons. Required number of separate dust Bins to collect wet waste and dry wastes shall be provided at important locations to collect the wastes generated by the visiting Turks and the visitors. The waste so collected shall then be scientifically disposed by the “Operator” on day to day basis.
- (c) The Operator shall appoint sufficient Parking attendants to facilitate the Parking operations to ensure that no damage is caused to the Buildings and its utilities, High Mast Lights, Structures, fencing poles, Chain Link fencing etc of the Truck Parking Terminal. In case of any damage caused due to irresponsible parking and usage, the Operator shall rectify the same at his own cost within 7 days from its occurrence. Failing which, Port shall carry out the restoration works at Operators’/Contractor’s risk and cost.
- (d) The truck terminal shall be operated round the clock with proper watch and ward.
- (e) The “Operator” shall also maintain proper co-ordination with various departments and Port Users for properly operating the terminal.
- (f) Only the Trucks, Trailers and Tankers transporting EXIM Cargo/ Coastal cargo shall be allowed to be parked in this Parking Terminal.
- (g) The “Operator” shall not carry out any activity that may be considered detrimental to the interest of the New Mangalore Port Authority or to the National Security.

- (a) The newly constructed KKGTP No-1 admeasuring 15980 Sqm will be handed over to the Operator for its Operation and Management after the issuance of Letter of Acceptance. The PQC work of the KKGTP No-1 is likely to commence shortly. In case the PQC works commences within the subject work contract period, the Authority may take over a part of KKGTP No-1 for executing the PQC works.
- (b) Similarly, an additional area may also be handed over to the Operator for operation. Hence, as and when additional area is either handed over to the "Operator" or taken over by the Authority for carrying out PQC/retrofitting/maintenance works, the Operator shall arrange to demarcate the up to date total area that has been handed over to the Operator and the increase or decrease in area will be recorded. The payments to be made by the "Operator" on account of increase or decrease in the area that has been handed over will be recalculated on pro-rata basis

based on the monthly premium License fee quoted by the Operator in the Quotation for operating and managing KKGTP No-1. The revised monthly premium License fee amount shall be with effect from the date of handing over of the additional area or taking of partial area by the Authority.

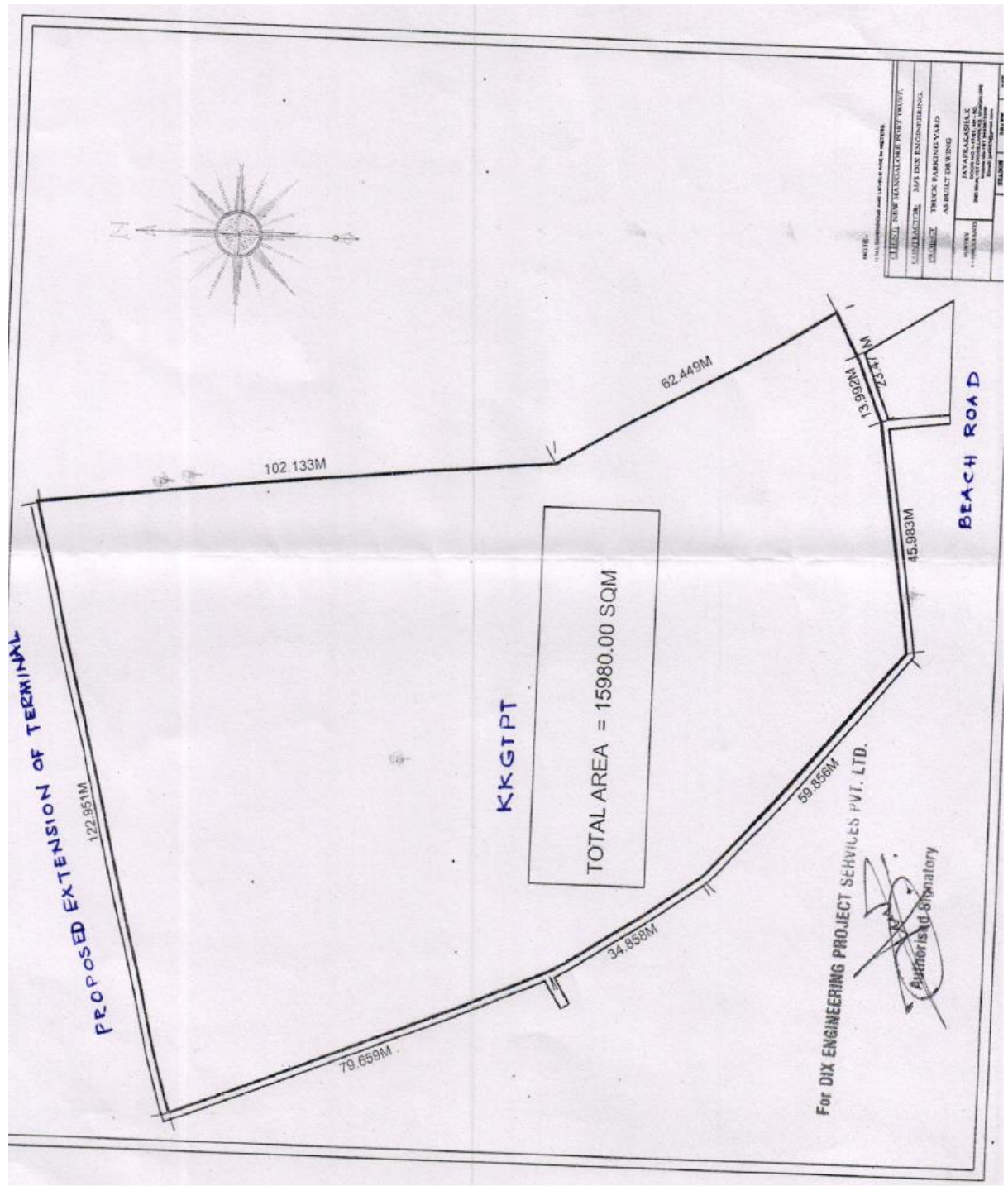
