Subject : Administration Department – Supply of Newspapers to various offices of NMPA for three years – Reg.

Sealed single stage single envelop/cover system quotations are invited from News Agencies on or before 15-30hrs of 19-09-2022 addressed to Secretary i/c, NMPA for supplying the Newspapers as per the terms and conditions. The sealed envelope should be clearly super scribed with the above Enquiry No., the due date and filled in prescribed BOQ format with checklist shall be dropped in the Tender Box kept at NMPA Administration Building (Near PR Section) Panambur, Mangalore-575010.

Terms and Conditions:

- 1. The price quoted should be inclusive of all applicable charges for delivery at NMPA offices, Panambur.
- 2. The supply of newspapers should be effected immediately after the issue of supply order, failing which the award shall be cancelled and EMD will be forfeited.
- 3. The period of the quotation shall be valid for three years from the date of notification of the award of contract.
- 4. Bidders should deposit EMD amount of Rs.4,500.00 (Rupees Four Thousand Five Hundred only) through RTGS in favor of FA&CAO, NMPA and scanned copy of RTGS payment details should be attached in RFQ, which is refundable without interest after awarding the contract to the unsuccessful bidder. The EMD of the successful bidder will be treated as Security Deposit, which is refundable without interest after the expiry of the contract.
- 5. The BOQ format in complete shape (Annexure-I) & as required shall be submitted along with proof of EMD, checklist (Annexure-II), other required documents in a closed sealed cover superscribed as "Quotation for Supplying of News Papers to various offices of NMPA for three years". So as to reach not later than 15-30 hrs on due date i.e., 19-09-2022 to the undersigned & the quotation will be opened on same day at 16-00 hrs in Secretary Office.
- 6. Quotations must be addressed to Secretary i/c, New Mangalore Port Authority, Panambur, Mangalore 575010 and should reach on or before above mentioned due date/ time.
- 7. The newspapers should be supplied/delivered within the stipulated time on or before 9-30 AM daily to various NMPA offices without any damage/loss.
- 8. The news agency will supply the newspapers without any interruption till the completion of contract. If the agency fails to supply the newspapers at various offices of NMPA before completion of contract, the agency shall be bound to pay the damages for default and

EMD will be forfeited. Damages, over and above the EMD will be recovered from the unpaid bills. The Agency should remit the penalty amount along with balance amount to FA&CAO, NMPA immediately.

- 9. Quotations must be given by the news agency duly sealed and signed by proprietor/partner/manager of the agency. Work order will be awarded to the lowest bidder.
- 10. The Agency shall have to submit the copy of PAN Card and GST Registration Certificate. If GST is not applicable necessary exemption document along with last year ITR shall be submitted.
- 11. The Agency shall also provide Bank details such as Name, Account Number, Account Type, branch IFSC Code for safer & easier payment transaction through RTGS/NEFT.
- 12. <u>Payment terms for Bidders</u> It will be mandatory for the bidders to indicate their bank account numbers and other relevant e-payment details so that payments could be through ECS/RTGS/NEFT mechanism instead of payment through cheque and payment will be made on a quarterly basis on receipt of bill. The bills of supplied News papers to various departments to be submitted by the contractor on Quarterly basis latest by the 7th day of the subsequent month to Secretary i/c, along with the requisition issued. Payment will be made within 15 working days from the date of receipt of bill through FA&CAO, NMPA subject to timely submission of bills along with relevant documents by the contractor.
- 13. Penalty for use of Undue influence: The bidder undertakes that he has not given, offered or promised to give, directly or indirectly, any gift, consideration, reward, commission, fees, brokerage or inducement to any person in service of NMPA or otherwise in procuring the work Orders or forbearing to do or for having done or forborne to do any act in relation to the obtaining or execution of the present Work Order or any other work order with the Government of India for showing or forbearing to show favour or disfavor to any person in relation to the present work Order or any other work Order with the Government of India. Any breach of the aforesaid undertaking by the bidder or any one employed by him or acting on his behalf (whether with or without the knowledge of the bidder) or the commission of any offers by the bidder or anyone employed by him or acting on his behalf, as defined in Chapter IX of the Indian Penal Code, 1860 or the Prevention of Corruption Act, 1986 or any other Act enacted for the prevention of corruption shall entitle NMPA to cancel the work Order and all or any other work Orders with the Bidder and recover from the Bidder the amount of any loss arising from such cancellation. A decision of NMPA or the nominee to the effect that a breach of the undertaking had been committed shall be final and binding on the Bidder. Giving or offering of any gift, bribe or inducement or any attempt at any such act on behalf of the Bidder towards any officer/employee of NMPA or to any other person in a position to influence any officer/employee of the NMPA for showing any fayour in relation to this or any other Work Order, shall render the Bidder to such liability/ penalty as NMPA may deem proper, including but not limited to termination of the Work Order, imposition of penal damages, forfeiture of the EMD and refund of the amounts paid by NMPA.
- 14. New Mangalore Port Authority may terminate the contract by giving one month's notice on the ground of unsatisfactory services.
- 15. The contract can be otherwise terminated without assigning any reason by either side by giving two months advance notice (60days). During the period of notice both the parties shall continue to discharge their duties and obligations.
- 16. NMPA reserves the right to any addition or alteration of the newspapers after awarding the contract.

- 17. NMPA reserves the right for inclusion/exclusion in the Terms and Conditions as per the requirement during or after awarding the contract.
- 18. Earnest Money Deposit of Rs.4,500.00 is to be paid by RTGS to NMPA Bank account, details as follows:-

20. All disputes are subject to the courts having Mangalore jurisdiction only.
