### **Terms and conditions:**

- 1. The rate quoted for supply of items shall be inclusive of all taxes & duties excluding GST and the same is firm and final. The rate quoted for Scope of Work shall be inclusive of all expenses such as labour cost, consumables, hardware required for modification to existing old Cable Tray supplied by the department & fixing of cable tray supports and laying of cable trays, consumables required for the work, transportation, tools & tackles and other incidental charges but excluding the items to be supplied by the department and reusable items. GST as applicable shall be paid extra. GST shall be quoted separately.
- 2. GST Certificate shall be enclosed along with the quotation.
- 3. The rate quoted should be valid for at least 45 **days** from the due date of submission of offer.
- 4. The Tenderer may visit the work site and get acquainted himself with the site conditions, nature of work involved before quoting, taking prior appointment with the undersigned or AEE(M), OTM Sub Division, NMPA. Any assistance in this regard will be provided by the Department.
- 5. The Supply of items shall be made within 30 days from the date of receipt of order (E mail/Hard copy) and complete the work within 10 working days thereafter.
- 6. During of the Berthing of Oil Tankers at Oil Jetty, the permission for carrying out the Welding/Chipping/Hot Work will not be allowed. Number of days for the completion of the work will be counted the days of non occupancy of tankers in Berth No.13 (Tanker Jetty No.5).
- 7. **LIQUIDATED DAMAGES**: In case of delay in completion of the work, liquidated damages (L.D) may be levied at the rate of 0.5% of the contract price plus applicable GST per week of delay, or part thereof subject to a maximum of 10 percent of the contract price.

- 8. The contractor shall obtain hot work permission from the competent authority of NMPT for carrying out the hot works. The copy of the same shall be given to AEE(M), OTM Sub Division before commencing the works.
- 9. Free electricity and water supply will be given for the said works.
- 10. Power supply will be given to the Contractor on free of cost. Tapping of power from the source point of NMPT to the required location will have to be arranged by the Contractor at his cost conforming to IE Rules / Standards.
- 11. The contractor shall be responsible for taking precautionary measures for the safety of the work men working under him and the responsibility arising due to any mishap during the execution of work, the payment of compensation, if any, lies entirely on the part of the Contractor. The Contractor has to employ skilled and competent workers for carrying out the work. The workmen shall have insurance cover during the course of execution of work.
- 12. Any damages to the departmental properties during the execution of works will be on contractors account.
- 13. The free wharf entry passes to the personnel (Red Pass) shall be provided by the Department as per the Rules. The required documents for the same shall be provided by the Contractor well in advance.
- 14. The work will be carried out to the entire satisfaction of Engineer in charge of the Department.
- 15. Payment Terms: Only 97% value of Total Tax Invoice payment will be made within 20 days after satisfactory completion of the work. Balance 3% of the Total Tax Invoice value will be retained as Security Deposit and will be released without interest after completion of Guarantee / Warrantee period.

- 16. The work carried out shall be guaranteed for a period of Six months from the date of satisfactory completion of the work.
- 17. Statutory taxes as applicable will be deducted while releasing payment.
- 18. The acceptance of the Quotations rests with the competent authority of NMPA who does not bind himself to accept the lowest Tender and reserves to himself the authority to reject any or all the Tenders received without assigning any reason.
- 19.The Competitive offer enclosed in a sealed cover super scribed as "Supply of Electrical Items and Laying, Dressing, Glanding, Termination, Testing & Commissioning of FS & FRLS cables in the Jetty / Service Platform area of Berth No. 13" should reach to the under signed on or before 03/11/2022 at 15:00 Hrs. to the below mentioned address. Quotation will be opened on the same day at 16.00 PM in the presence of the bidders who wish to be present.
