This project is planned and developed for the Automation of Weighbridge - New Mangalore Port Authority, Mangalore

- 1. The software built is a desktop based application (Electron Angular, MySQL)
- 2. The software has 8 Modules
- Trip Sheet Generator
- Material Master
- Customer Master
- Importer Master
- User/Operator Master
- Port Settings
- Shift Settings
- Reports
- 3. The Application built will listen to Weighbridge sensor via Serial Port, the data received will be displayed in the Trip Sheet Generator Form.
- 4. The application will store Data in MySql Server where the back end is developed using PHP. .

Application Flow:

- 1. Truck/Vehicle Driver Will Scan their RFID when entering the Weighbridge
- 2. RFID Data will be pushed to Weighbridge Application via Static IP (IP No 1
- Pushed from the Main Gate Software)
- 3. Application will read the RFID data dumped on the Database,
- 4. Application will then receive Ready signal from the Weighbridge sensor.
- 5. On receiving Ready Signal Application will read the Weight via the Sensor
- 6. Application will print the Trip Sheet Slip (Printer connected on a Static IP IP No 2)
- 7. Once the Print is performed a Go Signal will be pushed by the application for the vehicle to exit from the weight bridge
- 8. The Data received will be again pushed back to the API provided by the Main Gate Software
- 9. Email will be pushed for each tripsheet raised.
