1. The rate quoted for the items shall be firm and F.O.R destination basis. Please note that NMPA is not issuing any concessional **C or D forms**.
2. The Air Conditioners to be installed at the Following location :  
**Trade Promotion Centre, NMPA, Flat No. 622, D-Block, Natasha Golf View Apartment, Domlur, Bangalore**
3. Applicable GST will be paid as extra as per actual.
4. The time allowed for completion of work is **7 days** from the date of issue of work order.
5. Please note that no advance payment will be made. But payment will be made within 15 days after satisfactory completion of work and on receipt of firm bill.
6. The Tenderer may visit the work site and get acquainted himself with the site conditions, nature of work involved before tendering. Any assistance, in this regard will be provided by the department under prior appointment and the undersigned may be contacted for the purpose.
7. The Tenderer shall be responsible for making good of all the damages done during the work and has to employ skilled & competent workers for carrying out the work.
8. The Tenderer shall be responsible for taking precautionary measures for the safety of the workman working under them and the responsibility arising due to any mishap during the execution of work, the payment of any compensation etc., lies entirely on the part of the Contractor.
9. No tools, plant, Labour, equipment, transport, etc., required for the work will be supplied departmentally and contractor has to make his own arrangements.
10. The Tenderers should quote their rates in figures as well as in words the amount tendered by them. The amount per each item should be worked out and requisite total should be given. All rates shall be quoted in proper form in the tender schedule enclosed. The rates quoted should be valid for **90 days**.

11. The Items to be supplied should conform to the specifications and standards of IS & **warranty period of 12 months from the date of completion of work.**
12. The acceptance of the tender will rest with competent authority of NMPT who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all of the tenders received without assigning any reason.
