TERMS & CONDITIONS:

- 1. The rate quoted for the items shall be firm and F.O.R destination basis. Please note that NMPT is not issuing any concessional C or D forms. Quotation shall be submitted along with GST Registration without which the offer is liable for rejection.
- 2. Applicable GST will be paid as extra as per actual.
- 3. The Traffic Signal Light and other item should confirm to the specification and applicable standards.
- 4. The detailed Technical Specification/Brochures for the items such as signal light fittings, Count Down Timer, Cantilever MS Pole shall be submitted along with the offer.
- 5. The Technical details submitted by the Tenderer shall comply with the Technical Specifications of **BOQ** and the deviation if any shall be liable for rejection.
- 6. The time allowed for completion of work is **30 days** from the date of issue of work order.
- 7. The defect liability period for complete work of "Providing Cantilever Poles and Traffic Lights at Panambur Junction" is **12 months** calculated from the date of taking over.
- 8. **SECURITY DEPOSIT** @ 3% of contract value plus GST will be deducted from the bill and the same will be refunded after the expiry of Guarantee period of **12 months**.
- 9. **REPONSE / TURN AROUND TIME**: During the break down of the system at any time, the contractor required to set right/rectify the problem within 24 Hrs of the complaint.
- 10. **DAMAGE CHARGES**: In case of failure to restore the complete system within 24 hrs, Damage Charges will be levied/imposed & Rs. 500/- per day and the same will be recovered from the **Security Deposit**.
- 11. Please note that no advance payment will be made. But payment will be made within 15 days after satisfactory completion of work and on receipt of firm bill.

- 12. The Tenderers should quote their rates in figures as well as in words the amount tendered by them. The amount per each item should be worked out and requisite total should be given. All rates shall be quoted in proper form in the tender schedule enclosed. The rates quoted should be valid for 90 days.
 - 13. The Tenderer may visit the work site and get acquainted himself with the site conditions, nature of work involved before tendering. Any assistance, in this regard will be provided by the department under prior appointment and the undersigned may be contacted for the purpose.
 - 14. The Tenderer shall be responsible for making good of all the damages done during the work and has to employ skilled & competent workers for carrying out the work.
 - 15. The Tenderer shall be responsible for taking precautionary measures for the safety of the workmen working under him and the responsibility arising due to any mishap during the execution of work, payment of any compensation etc., lies entirely on the part of the Contractor. Safety Items required while working are to be provided by the Contractor.
 - 16. No tools, plant, Labour, equipment, transport, etc., required for the work will be supplied departmentally and contractor has to make his own arrangements.
 - 17. The evaluation shall be done on the basis of total lowest value (L1) quoted. The GST element if any will not be considered for evaluation.
 - 18. The acceptance of the tender will rest with competent authority of NMPA who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all of the tenders received without assigning any reason.
 - 19. Department Standard Operating Procedure will be shared with the successful bidder before commencing the work and an undertaking will be obtained for complying with the same. In case if the Contractor does have a defined SOP for carrying out the work, the same shall be scrutinized and approved by the Executive Engineer (E)-I for its applicability.
 - 20. If the Tenderer after award of work/contract fail to execute the work in the specified allotted period, then the Tenderer shall be debarred for a period of three (3) years from participating for tenders at New Mangalore Port Authority.
