Terms and conditions:

- 1. The job and new float cum boost battery charger must be thoroughly inspected prior to quoting. Rate to be quoted excluding GST. GST as applicable would be paid extra.
- 2. The required tools and plant, labour, materials, consumables etc. should be arranged by the contractor. Requisite insurance coverage for the transit to be obtained.
- 3. All measures ar d aspects to be adapted to protect environment to comply with ISM/ ISO standards. Working personnel should make use of proper PPE and follow safety regulations. Hot work if any has to be carried out with due approval/hot work permit from port fire service. The firm shall comply with all applicable ESI and labour acts.

- 4. Guarantee/warrantee for workmanship: Standard Engineering practices and quality workmanship are to be adhered to. Repairs/services shall be guaranteed for a period of six (06) months against workmanship. Defects occurred due to poor workmanship should be attended free of cost at the earliest opportunity. All works shall be subjected to stage and final inspection.
- 5. Tug has sophisticated automation system. Any damage to the interlinked electronic system of the tug or any damage occurred to any other PLC board in the system during works should be borne by the contractor.
- 6. Full payment wil be made within 15 days after satisfactory completion of works, trials and on submission of bill. Income tax as applicable would be deducted from the bill, at the prevailing rates.
- 7. Rate quoted must include cost of consumables, labour, etc. and must be in realistic manner based on present market rate. Charges for travelling, accommodation, boarding, conveyance etc of the working personnel should be borne by the contractor.
- 8. Quotation with counter condition by the firm shall be liable for rejection.
- 9. Any damage to the port properties during repairs will be at contractor's account.
- 10. All works must be carried out to the entire satisfaction of the Engineer-incharge.
- 11.All released materials must be handed over to the Engineer-in-charge with proper acknowledgement.
- 12. Time allowed for completion of work is five working days.
