This has reference to your online proposal No. IA/KA/MIS/21480/1910 dated 9th August 2016, submitted to this Ministry for grant of Extension of Validity of Environmental and CRZ Clearance to the above referred project in terms of the provisions of the Environment Impact Assessment (EIA) Notification, 2006 under the Environment (Protection) Act, 1986 and CRZ Notification, 2011.

2. The proposal for grant of Extension of validity of Environmental and CRZ Clearance to the project was considered by the Expert Appraisal Committee (Infra-2) in its meetings held on 25th-27th May, 2017.
