Sub: Rationalisation of tariff for cruise vessels arriving in India.  
Ref.: Letter No. SW-15011/2/2020-Cruise Shipping dtd. 24.07.2023  
of Ministry of Ports, Shipping and Waterways.

Ministry of Ports, Shipping and Waterways vide letter cited above has communicated approval of the Competent Authority to continue the ongoing rationalisation of tariff for Cruise Vessels further for one more season starting from 1<sup>st</sup> October 2023.

Accordingly, the Composite charges for cruise vessels for a period of one-year w.e.f 1<sup>st</sup> October 2023 shall be as under:

	For Cruise vessels:		
1.	For first 12 hours	Per GRT	0.085
2.	For each additional hour or part thereof exceeding 12 hours	Per GRT	Berth hire charges prescribed under Clause No. 2.2 of SOR.
3.	Passenger Charges	Per Passenger	6.0

**Note:**

1. The Port will not charge any other rate like berth hire for first 12 hours, port dues and pilotage.
2. The Passenger Charges shall be applicable to all passengers i.e., Transit/ Embarkation/ Disembarkation.
3. Following rebates will be applicable:
