TITLE OF WORK: TENDER FOR "PROCUREMENT OF 120 BRANDED MEDICINES THROUGH MULTIPLE SOURCE".

- बोलीदाता को होम पेज में उपलब्ध क्लिक हियर टू एनरोल का उपयोग करके पोर्टल में ऑनलाइन नामांकन करना चाहिए। फिर पोर्टल पर लॉग इन करने के बाद ई-टोकन के साथ डिजिटल सिग्नेचर एनरोलमेंट करना होगा। Bidder should do Online Enrolment in the Portal using the option Click Here to Enroll available in the Home Page. Then the Digital Signature enrollment has to be done with the e-token, after logging into the portal.

2. INSTRUCTIONS TO THE BIDDERS (ITB)

2.1 SCOPE OF BID

- 2.1.1 E- tenders in Two Cover system (Techno-Commercial Bid and Price Bid) are invited by Chief Medical Officer on behalf of New Mangalore Port Hospital from the reputed, bonafide, resourceful & experienced Manufacturer / Authorized distributo for the work of "PROCUREMENT OF 120 BRANDED MEDICINES THROUGH MULTIPLE SOURCE".
- 2.1.2 The successful bidder will be expected to render services as specified in the scope of supply as per tender clause 4.0 of this tender document.

2.2 <u>TENDER SUBMISSION</u>:

The Tender shall be uploaded as follows:

- 2.2.1 Technical Bid shall contain the following :
 - a) EMD shall be uploaded along with the bid as per tender clause no 2.12. The tender not accompanied with EMD shall be summarily rejected except in case of 2.2.1(m) of ITB.
 - b) TENDER FEE for Rs.1,680/- (Rupees One Thousand six Hundred and eighty Only) inclusive of 12% GST - Non-refundable - RTGS Receipt shall be uploaded along with the Technical Bid. Failure in submission of Tender fee will render the bidders disqualified, except in the case as per clause No 2.2.1 (m) below.
 - c) All the documents as per the MQC as per clause No 2.4. Technical Bid should not contain Price Bid. "Disclosure/indication of Price in the Technical Bid shall render the tender disqualified and rejected.
 - d) The Tender document duly signed and sealed by the Tenderer on each page with Annexures duly filled along with amendments issued by NMPA if any.
 - e) Particulars of Bidder as per Annexure -1.
 - f) Tender Form/ undertaking as per Annexure-2.
 - g) Bank Details of the Tenderer for E-Payment Annexure-4
 - h) Copies of the GST Registration Certificate and PAN card to be submitted in the name of Bidder.
 - i) Form of Declaration Annexure-5.
 - j) The instruments such as Power of Attorney, Resolution of Board etc., authorizing an officer of the Bidder should be enclosed: - Annexure -6.
 - k) Undertaking on Idemnification- Annexure 7.
 - 1) List of items quoted and its Specification must be submitted along with Technical Bid Envelope in the Format given at Annexure-8 without indicating price.
 - m)Micro Micro and Small Enterprises (MSE) registered with District Industries Centre (DIC) or Khadi and Village Industries commission or Khadi & Industries Board (KVIB) or Coir Board

or National Small Industries Corporation (NSIC) or Directorate of Handicrafts and Handlooms or Udyam Registration certificate or any other body specified by Ministry of MSME shall be exempted of EMD and tender fee on producing self attested supporting certificates along with Technical Bid.

- n) All copies of the documents submitted in the subject tender including Annexures shall be selfattested by the bidder.
- o) An undertaking, that the firm/ successful bidder are ready to supply the medicines at the quoted or discounted rate for a period of one year from the date of issue of supply order.
- 2.2.2 Price Bid shall be uploaded only through ONLINE: Technical Bid and Price Bid shall be uploaded through online only. Price bid should be quoted in the BOQ template available in the CPP portal only. The BOQ template must not be modified/ replaced by the bidder and the same should be uploaded after filling the relevant columns, else the bidder is liable to be rejected for that tender. Bidders are allowed to enter the Bidder Name and Values only. Any condition imposed in the price bid shall make the tender liable for out-right rejection. The contract shall be for the entire supply as described in the scope of supply based on the priced Bill of Quantities submitted through CPP portal by the Bidder. The Bidder shall fill in rates and prices for all items of the works described in the Bill of Quantities through CPP portal. Items for which no rate or price is entered by the Bidder will not be considered for evaluation.

2.3 <u>ELIGIBLE BIDDER:-</u>

- 2.3.1 The invitation for bids is open to all eligible Bidders meeting the eligibility criteria as defined in clause No 2.4.
- 2.3.2 All bidders shall provide Tender Form information as per Annexure -2.
- 2.3.3 Government owned enterprises may only participate if they are legally and financially autonomous operate under commercial law and are not a dependent agency of the employer subject to fulfillment of minimum qualifying criteria.
- 2.3.4 Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by the employer in accordance with clause No 2.26.

2.4 MINIMUM QUALIFICATION CRITERIA OF THE BIDDERS: (MQC)

Pharmaceutical firms, who are manufacturing the drugs, are eligible to quote directly or through their Authorized Dealers / Distributors / stockist subject to the condition that they satisfy the following Minimum Qualification Criteria and furnish all the following documentations:

2.4.1 The The tenderer should have an average Annual Financial turn over not less than 30% of the estimate amount of the medicines quoted by him for the last 3 years 2020-21, 2021-22 & 2022-23.

Note:- Documentary evidence duly self attested viz - auditor's certificates / balance sheet /

latest income tax return filed/profit and loss statement for the three years shall be uploaded along with the bid.bidders have to mandatorily submit the details of drugs quoted; in Annexure-8 (Please refer Annexure-8 for further details).

- 2.4.2 The bidders have to mandatorily submit the details of drugs quoted; in Annexure-8 (Please refer Annexure-8 for further details).
- 2.4.3 The bidder shall furnish self-attested copy of valid Drug Manufacturing License from the Competent Authority. Incase of Imported medicines, self attested copy of the valid import licence issued by the concerned authorities shall be submitted. A copy of a valid licence for the sale of Drugs imported by the firms issued by the licensing authority shall be enclosed. The license must have been duly renewed / valid up to date. In case the Bidder has applied for renewal of his drug License (application should be at least within last 1 month of expiry of his license(s), copy of acknowledgement / receipt of Renewal application with State drug Licensing authority needs to be uploaded.
- 2.4.4 In case of Authorized Dealers / Distributors / stockist submitting bids for this tender on behalf of their Manufacturer, they should furnish Authorization letters from the respective manufacturers, duly complying the Clause No: 2.4.3 and shall have the Drug license in their bidders name issued by the concerned authorities to sell/ stock/ distribute medicines failing which the bid shall be summarily rejected.
- 2.4.5 Incase of the bidder being a Marketing firm who has authorized manufacturing of their medicines to third parties shall submit the drug license, GMP certificate of the manufacturer along with the technical bid. They shall also submit the self attested copy of the agreement or any other relevant document between the bidder and the manufacturer for manufacturing the quoted medicines.
- 2.4.6 Pharmaceutical Companies should furnish Self-attested Valid Good Manufacturing Practices Certificate (GMP) or WHO-GMP Certificate from the concerned authorities. The GMP certificate must not be older than one year from the due date of Bid submission in the case where validity is not mentioned in the certificate.
- 2.4.7 The bidder shall give a self declararation that he has not been convicted, blacklisted and the product has not been declared as not of standard quality during last Five years in the Company's Letter Head. If on a later date, it is found that the declaration submitted by the bidder is false, the firm shall be blacklisted and disqualified from participating in NMPA tenders for a period of three duly forfeiting EMD/Security deposit as applicable.
- 2.4.8 The Bidder should have experience in the field of Supply of Medicines to any reputed Firms. Copies of supply order issued by the client duly self attested shall be submitted as documentary evidence.

- 2.5 If bidder is a manufacturer,
 - 2.5.1 Bank Guarantee shall be submitted either by the Manufacturer/ by his Authorised Distributor.
 - 2.5.2 Work Order will be issued only to the successful bidder.
 - 2.5.3 Supply can be made effected through the Authorised distributor subject to declaration of the name and address of the Distributors in technicical bid.
 - 2.5.4 Payment for the supply of medicines by the distributor shall be made as per the instructions/ declaration of the Manufacturer in the Technical Bid (successful bidder).
 - 2.5.5 However Manuafacture/ Bidder is responsible for fulfillment of all terms and condictions of the tender.
- 2.6 Even though the Bidders meet the qualifying criteria as per clause 2.4, they are subject to be disqualified and debarred for a period of 3 years from participating for tender at New Mangalore Port Authority with forfeiture of EMD/ duly informing the MSME authority, if they have:
 - 2.6.1.1 made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
 - 2.6.1.2 Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion or financial failures etc.
- 2.7 **LAST DATE FOR SUBMISSION OF TENDER:** NMPA may at its sole discretion reserves the right to extend the date for receipt of tender.

2.8 RATES TO BE INCLUDED FOR ALL EXPENSES:

- 2.8.1 The price should indicate lump sum price including cost of the item, freight, insurance, transit insurance, packing, forwarding, sales tax, excise duty, etc. excluding GST. No other charges in addition will be payable on any account over and above the lump sum price quoted. Offers with price variation clause will not be accepted. The rates quoted in ambiguous terms such as "Freight on actual basis" or "Taxes as applicable extra" or "Packing forwarding extra" will render the bid liable for rejection irrespective of its gradation in respect of lump sum prices quoted.
- 2.8.2 Rates quoted should be per unit i.e., per tablet/capsule/bottle/cream/vial/amppule in price bid MRP/Offered price/GST should clearly specified. The rates quoted is FOR to NMPA Hospital Panambur, Mangalore
- 2.8.3 All the rates should be mentioned in Indian national rupee (INR) only. The rates quoted in foreign currency will not be entertained in this tender enquiry & such tenders will be cancelled straightaway.
- 2.8.4 The Price quoted should be firm till the completion of the contract and no upward revision will be accepted. Any hike/decrease in applicable GST will be paid by NMPA at actual (copy of the Notification shall be enclosed).

2.8.5 If the price of the contracted articles is / are controlled by the Government, in no circumstances the payment will be higher than the controlled rate.

2.9 <u>AUTHORITY IN SIGNING TENDER DOCUMENTS</u>:

- 2.9.1 The tender, if submitted on behalf of a Partnership Firm should be signed either by all the partners or some of the partners or other person/s holding a valid "Power of Attorney" from other partners or all the partners constituting the firm.
- 2.9.2 In case of a Company, the tender should be signed by a person holding a valid Power of Attorney executed in his favour in accordance with the constitution of the Company.

2.10 ONE BID PER BIDDER

- 2.10.1 Each bidder shall submit only one bid for one package. A bidder who submits or participates in more than one Bid (other than as a subcontractor or in cases of alternatives that have been permitted or requested) will cause all the proposals with the Bidder's participation to be disqualified.
- 2.10.2 A Bidder shall not have a conflict of interest. All Bidders found to have conflict of interest shall be disqualified. Bidders may be considered to have a conflict of interest with one or more parties in this Tendering process, if they are or
 - 2.10.2.1 Have been associated in the past, with a firm or any of its affiliates which have been engaged by the Employer to provide consulting services for the preparation of the design, specifications, and other documents to be used for the services to be rendered under these Tendering Documents ; or
 - 2.10.2.2 Submit more than one Tender in this Tendering process.
- 2.10.3 A Bidder that is under a declaration of ineligibility by the Employer in accordance with ITB Clause 2.26, at the date of contract award, shall be disqualified.
- 2.10.4 Bidders shall provide such evidence of their continued eligibility satisfactory to the Employer, as the Employer shall reasonably request.

2.11 BIDDER TO INFORM HIMSELF FULLY

- 2.11.1 The Bidder is expected to examine carefully the contents of all the documents provided like instructions to the Bidders, Tender Conditions, Scope of supply etc. Failure to comply with the requirements of the tender will be at the Bidders own risk. The Bidder to ensure to make a complete and careful examination of requirements and other information set out in the tender document.
- 2.11.2 Bidder shall bear all costs associated with the preparation and submission of his tender and NMPA will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the tendering process.

2.12 EARNEST MONEY DEPOSIT (EMD) / BID SECURITY

- 2.12.1 The tender shall be accompanied with Earnest Money Deposit @ 2% +18% GST on MRP value of the quoted medicines by the bidders. For example, if the bidder has quoted for 30 branded medicines at the MRP amount of Rs 55000/-. i.e Rs55000 x 2%EMD value = 1100 + 18% GST Service tax = 1298 say 1300/-. The bidder shall submit the EMD of Rs1300/-. The tender not accompanied with EMD shall be summarily rejected except in case of clause 2.2.1(m)
- 2.12.2 The EMD may be accepted in the form of insurance Surety Bonds, Account payee Demand Draft, Fixed Deposit receipt, Bankers Cheque or Bank Guarantee from any of the Commercial Banks or Payment Online in an acceptable form, safeguarding the purchases interest in all respects. The Bank Guarantee for the entire amount from any Nationalised / Scheduled Bank (not from Co-operative Banks) from any branch in India. Bank Guarantee submitted as Earnest Money as per Annexure 9 and shall be valid for 28 days beyond the validity of the bid. Bank Guarantee shall be verified independently by the Port with the bank before finalization of Techno-Commercial and priced Bid. In the event of lack of confirmation of issue of the Bank Guarantee by the Bank, the bid shall stands disqualified. The BG shall be uploaded along with the Bid documents. The hard copy in original shall be sent to this Office immediately after the opening of the Technical bid. The Bank Guarantee shall be on a non-judicial stamp paper of Rs.100/-. The Bank Guarantee shall be extended suitably if there is a delay in awarding the contract. The relevant extension shall be on Bidders account. EMD will not carry any interest.
- 2.12.3 The Earnest Money Deposit of the unsuccessful Tenderers shall be returned without interest as early as possible on award of Contract to the successful Tenderer. The Earnest Money Deposit of the successful Tenderer shall be refunded (without interest) only on receipt of Performance Bank Guarantee as stipulated in the tender.
- 2.12.4 In the event of forfeiting the EMD/Liquidated damages/Security deposit, GST is applicable and while imposing penalty GST as applicable shall be collected.
- 2.12.5 The EMD may be forfeited, or the firm may be debarred for a period of three (3) years from participating for tenders at New Mangalore Port Authority duly informing the MSME authorities (if the firm has claimed EMD and tender fee exemption),if

2.12.5.1 The Bidder withdraws the Bid after Bid opening during the period of Bid Validity

2.12.5.2 The successful Bidder fails within the specified time limit to.

- 2.12.5.3 Sign the Agreement AND / OR furnish the required Performance security.
- 2.12.5.4 Fail to commence the supply on the specified date as per LOA/Work order.

- 2.12.5.5 If the bid is varied or modified in a manner not acceptable to the Employer during the validity or extended validity period duly agreed by the Bidder.
- 2.12.5.6 If any information or representation submitted by Bidder is found to be false or incorrect.
- 2.12.5.7 Any effort by the Bidder to influence the Employer on bid evaluation, bid comparison or contract award decision.
- 2.13 <u>TENDER VALIDITY</u>: The tender shall remain valid for acceptance for a period of 120 days from the date of opening of Technical Bid. NMPA reserves their right to extend the period of validity for a specific time. The request and the response, thereto, shall be made in writing by post or by Fax/e-mail. A bidder may refuse the request which may be accepted by NMPA. However, in the event of the Bidder agreeing to the request; he shall not be permitted to modify his tender.

2.14 AMENDMENTS:

- 2.14.1 At any time, prior to the last date for submission of tenders, NMPA reserves the right to amend and modify the tender document by issuing Addendum/Corrigendum which shall be uploaded in the CPP/PORT Websites.
- 2.14.2 The Addenda/Corrigenda so issued shall form part of the Contract and shall be binding upon the Bidders. NMPA may at their discretion, extend the last date for submission of the tender, to enable the Bidders to have reasonable time to submit their tender after taking into consideration such amendments, which shall also be uploaded to the Websites. The Bidder shall acknowledge receipt of such Addenda/Corrigenda and submit the same along with his Tender duly signed and sealed in all pages.

2.15 <u>LANGUAGE OF TENDER</u> :

The Tender submitted by the Bidder and all correspondence and documents relating to the Tender exchanged by the Bidder and the NMPA shall be written in the <u>English language</u>. Any printed literature, other than English language, shall be accompanied by an English translation, in which case, for purpose of interpretation of the tender, the English translation shall govern.

2.16 MODIFICATION, SUBSTITUTION AND WITHDRAWAL OF PROPOSAL:

No offer shall be modified, substituted or withdrawn by the Bidder after the closing time on due date. Withdrawal of a proposal during the interval between closing time on proposed due date and expiry of the proposal validity period, action may be taken in accordance with clause 2.12 of Tender Document.

2.17 <u>TENDERED CURRENCIES:</u>

Prices shall be quoted in Indian Rupees only and all payments will be made in Indian Rupees.

2.18 <u>PRE BID QUERIES</u>

Pre-bid queries shall be uploaded online only in the e-procurement portal on or before 03/09/2023 at 13:00 Hrs. Queries through hard copy or email shall not be entertained. The response to the queries/clarification received from the Bidders shall be uploaded on CPP websites. No pre-bid meeting will be held with the prospective Bidders.

2.19 TENDER OPENING AND EVALUATION:

2.19.1 <u>OPENING OF TECHNICAL BID</u>: Technical bids of the Tender, received up to closing time on stipulated date, shall be opened as per the Important Instructions of CPP.

2.19.2 SCRUTINY AND EVALUATION OF THE TENDER

- 2.19.2.1 Prior to the detailed evaluation of bid, the employer will determine whether each bid(a) meets the eligibility criteria defined at 2.4 above (b) has been properly signed byan authorized signatory holding Power of Attorney in his favor (c) accompanied byEMD & Tender fee and (d) is responsive to the requirement of the bidding documents. If any of the above conditions are not satisfied, the bid shall be rejected outright.
- 2.19.2.2 Conditional offer or alternative offers will not be considered further in the process of tender evaluation.
- 2.19.2.3 A substantially responsive technical and Financial Bid is one which conforms to all the terms, conditions and specifications of the bidding documents, without material deviation or reservation. A material deviation or reservation is one (a) which affects in any substantial way the scope , quality or performance of the works; (b) which limits in any substantial way, the employers right or bidders obligations under the contract or (c) whose rectification would affect unfairly the competitive position of others bidders presenting responsive bids. The Bidder who does not fulfill the tender requirements shall not be considered for further evaluation.
- 2.19.2.4 After the tender opening, the whole process involving scrutiny, clarifications, evaluation and comparison of tenders and recommendations regarding award of Contract shall be confidential. Any efforts on part of any Bidder to influence the Port Authority in any way in the process of scrutiny, evaluation, comparison of tenders and decision concerning award of Contract may result in rejection of the Bidder's bid.
- 2.19.2.5 To assess the scrutiny, evaluation and comparison of tenders, the Port Authority may ask Bidder individually for clarifications. Clarifications shall be sought only on the documents submitted along with the bid. No new documents/work orders shall be entertained which was not part of the original submission whose acceptance would affect unfairly the competitive position of other bidders presenting responsive bids. Request for clarification and response thereto shall be in writing/email or through fax. If the Bidder fails to submit the requested documents within the time specified by the

department, his bid is liable to be rejected. No change in Price or substance of the tender shall be sought, offered or permitted nor is the Bidder permitted to withdraw the tender before the expiry of the validity period of the tenders in the process of clarifications.

2.19.2.6 If a Technical Bid is not substantially responsive, it will be rejected by the employer, and may not subsequently be made responsive by correction or withdrawal of the non conforming deviation or reservation. The Price/Financial Bid of those bidders shall not be opened.

The Committee constituted by the Competent Authority NMPA, Mangalore will technically evaluate the items on the basis of specification as per Price Bid Format (PART III), make / brand quoted; literature enclosed, sample submitted wherever asked, the authority from manufacturer for the item etc. The items accepted technically will only be considered for price evaluation (price bid). Price should not be uploaded with technical bid, then the tender will be rejected without any correspondence.

2.20 OPENING OF PRICE BID:

- 2.20.1 Those Tenderers who were shortlisted on technical bid evaluation will be called for price bid opening. The Tenderers will be intimated the date and time of Price bid opening.
- 2.20.2 The Technical Responsive bidders' Financial Bid shall only be opened and L-1 bidder shall be decided on the basis of each Item-wise lowest rate quoted by any of the bidder excluding GST. Pack size of each item should be clearly required to be mentioned. If more than one bidder becomes L1, the order quantity will be equally distributed among them. Further, a portion of required quantity will be distributed as per Cl.No 2.21(b) & (c).
- 2.20.3 The Tenderer whose Price Bid is found to be the lowest and/or beneficial to the Port Authority shall be considered for award of Contract. The Tenderer whose bid is accepted by the Port Authority, shall be duly informed in writing. Within 15 days of receipt of intimation, regarding acceptance of its bid.
- 2.20.4 If the Bid of the successful Bidder is seriously unbalanced in relation to the Chief Medical Officer or his Representative's estimate of the cost of work to be performed under the contract, the Employer may require the Bidder to produce detailed price analysis for any or all items of the Bill of Quantities, to demonstrate the internal consistency of those prices with the implementation/construction methods and schedule proposed.

- 2.20.5 Offers, deviations & other factors which are in excess of the requirement of the Tender document or otherwise result in the accrual of unsolicited benefits to the Employer shall not be taken into account in Tender evaluation.
- 2.20.6 The price Bid with any counter conditions will be summarily rejected.

2.21 MSME CONDITIONS:

- a. Among all bids, the lowest bid will be termed as L1, if L1 is Micro and small Enterprises registered with MSME, the contract will be awarded to L1.
- b. If L1 is not from Micro and small Enterprises registered with MSME and the tendered quantity is divisible in nature, than the tenderer participating Micro and small Enterprises quoting price within price band L1+15 per cent shall also be allowed to supply a portion of requirement by bringing down their price to L1 price in a situation where L1 price is from someone other than a Micro and Small Enterprise and such Micro and Small Enterprise shall be allowed to supply up to 25 per cent of total tendered value.
- c. Out of the 25% reservation to MSE's, 4% is to be reserved for MSE's owned by SC & ST and 3% to MSE's owned by women.
- d. The above facility is applicable only where it is possible to split the quantity among the bidders.

2.22 AWARD OF CONTRACT

Award Criteria

The employer will award the contract to the bidder whose bid has been determined to be responsive to the bidding documents and who has offered the highest rebate offered, provided that such bidder has been determined to be (a) eligible in accordance with the provisions of Clause No 2.3 and (b) qualified in accordance with the provisions of clause No 2.4.

2.23 EMPLOYERS RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL

Notwithstanding Clause no 2.20, the employer reserves the right to accept or reject any bid and to cancel the bidding process and reject all bids, at any time prior to the award of contract, without thereby incurring any liability to the affected bidder or bidders of the grounds for employer's action. Further, NMPA does not bind them to accept the lowest offer.

2.24 NOTIFICATION & AWARD OF CONTRACT

- **2.24.1** The bidder whose bid has been accepted will be notified of the award by the employer prior to expiration of the bid validity period. This letter (herein after and in the conditions of contract called the " letter of acceptance") will state the sum that the employer will pay the contractor in consideration of the execution completion and maintenance of the works by the contractor as prescribed by the contract (hereinafter and in the contract called the "contract price").
- 2.24.2 The notification of award will constitute the formation of the contract subject only to the

furnishing of a performance security in accordance with the provision of clause 2.25.

- **2.24.3** The Supply order itself binds as agreement for the subject contract for supply of Branded Medicines to Port Authtoiry Hospital.
- 2.25 <u>PERFORMANCE SECURITY</u>: shall be 3% of the total supply order value including GST and should be submitted in the form of Bank Guarantee from any Nationalized/Scheduled Bank having branch at Mangalore in the approved format within 28 days from the date of issue of work order. The Performance Security may be accepted in the form of Insurance Surety Bonds, Account Payee Demand Draft, Bankers Cheque and Fixed Deposit Receipt from a Commercial Bank. The Bank Guarantee shall be kept valid for the total contract period Plus Six months claim Period. This Security Deposit shall be released to the Contractor after successful completion of Contract and deducting any dues payable to the Port. Failure to comply with the above shall lead to termination of contract. If the contract is extended on mutual consent at the same rates, terms and conditions of the contract, then the Bank Guarantee shall also be extended for the same period plus 6 months claim period.

<u>Note:-</u> The Penalty for the delay in submission of the Performance guarantee within the stipulate date above shall be at the rate of 0.25% of the amount of performance guarantee for each week or part of the week for the number of weeks delayed beyond the stipulated date of submission which shall be deducted from the dues payable to the bidder.

2.26 CORRUPT OR FRAUDULENT PRACTICES

The Employer requires that Bidders/Suppliers/Contractors under this contract, observe the highest standard of ethics during the procurement and execution of this contract. In pursuance of this policy, the Employer

2.26.1 defines, for the purpose of these provisions, the terms set forth below as follows:

- 2.26.1.1 "corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution; and
- 2.26.1.2 "fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Employer, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Employer of the benefits of free and open competition.
- 2.26.2 Will reject a proposal for award of work if he determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.
- 2.26.3 will declare a Bidder ineligible, either indefinitely or for a stated period of time, to be awarded a contract/contracts if he at any time determines that the Bidder has engaged in

2.27 <u>THE LAW, WHICH APPLIES TO THE CONTRACT</u>

The Contract shall be governed by the Indian Contract Act and under the Indian Law. The Arbitration for settlement of disputes shall be held in Mangalore, Karnataka, India.

2.28 <u>SETTLEMENT OF DISPUTES:</u>

2.28.1 AMICABLE SETTLEMENT/DISPUTE REVIEW BOARD:

If disputes of any kind arises between the Board and the Contractor in any connection with, or arising out of the Contract or the execution of the contract whether during the execution of the contract or after the completion and whether before or after repudiation or other termination of the Contract, including any dispute as to any opinion, instruction, determination, certificate, the mater in dispute shall in the first place, be referred in writing to the Chief Medical Officer and an attempt shall first be made by all the parties to settle such dispute amicably, with a copy to the other party. Such reference shall state that it is made pursuant to this clause.

If the Contractor believes that a decision taken by the Chief Medical Officer Representative was either outside the authority given to the Chief Medical Officer, Representative by the Contract or that the decision was wrongly taken, the decision shall be referred to the Dispute Review Board (DRB) within 28 days of the notification of the Representative decision.

Unless the Contract has already been repudiated or terminated, the Contractor shall, in every case, continue to proceed with the works with all due diligence and the Contractor and the Employer shall give effect forthwith to every such decision of the Chief Medical Officer unless and until the same shall be revised, as hereinafter provided, in a Dispute Review Board or an arbitral award. The Dispute Review Board (DR Board) will be constituted after award of Contract.

Provided that, unless the parties otherwise, agree, arbitration may be commenced on or after the fiftysixth day after the day on which notice of intention to commence arbitration of such dispute was given, whether or not any attempt at amicable statement thereof has been made.

2.28.2 ARBITRATION:

Except where otherwise provided for in the contract, all questions and disputes relating to the meaning of the words, terms, specifications, operations, and instructions, mentioned in this contract and as to the quality of workmanship or performance of handling and any other question, claim, right, matter or thing whatsoever in any way arising out of or relating to the contract, specifications, operating instructions, orders or these conditions; or otherwise concerning the transport and handling operations, the execution or failure to execute the same whether arising during the progress of the work or after the completion or abandonment thereof, shall be referred to a sole arbitrator to be appointed by the Tender Accepting Authority of NMPA. There will be no objection if the arbitrator so appointed is an ex-employee of NMPA.

If the Arbitrator, to whom the matter is originally referred, is transferred or vacates his office or is

unable to act for any reason, the Tender Accepting Authority of NMPA, as aforesaid at the time of such transfer, or vacation of the office or inability to act, shall appoint another person to act as Arbitrator in accordance with the terms of the contract. Such person shall be entitled to proceed with the reference from the stage, at which it was left by his predecessor.

Subject as aforesaid, the provisions of the Arbitration and Conciliation Act 1996, or any statutory modification or re-enactment thereof, and the rules made there under, and for the time being in force shall apply to the arbitration proceeding under this clause.

It is a term of the contract that the party invoking arbitration shall specify the disputes to be referred to arbitration under this clause together with the amount or amounts claimed in respect of each dispute. The Arbitrator may, with consent of the parties, fix and/or enlarge the time for making and publishing the award as situation warrants.

The work under the contract shall, if reasonably possible, continue during the arbitration proceedings and no payment due or payable to the contractor shall be withheld on account of such proceedings.

The Arbitrator shall be deemed to have entered on the reference on the date on which he issues notices to both the parties fixing the date of the first hearing.

The Arbitrator shall have power to call for such evidence by way of affidavits or otherwise as the Arbitrator shall think proper and it shall be the duty of the parties hereto to do or cause to be done all such things as may be necessary to enable the Arbitrator to make the award without any delay.

The Arbitrator shall give a separate award in respect of each dispute or difference referred to him. The venue of arbitration shall be such place as may be fixed by the Arbitrator in his sole discretion. The award of the Arbitrator shall be final, conclusive and binding on all parties to the contract. In case of any disputes or differences between the parties hereto, the court at Mangalore shall alone have jurisdiction to entertain the suit/arbitration award.

<u>2.28.3</u> Apart from the above, conciliation through conciliation committees/councils comprising of independent subject experts may also be explored to settle the disputes.

3.0 GENERAL TERMS AND CONDITIONS (GTC):

- **3.1** It must be mentioned clearly whether Tenderer is a manufacturer / Distributor/Stockist for the items for which he is quoting.
- **3.2 Manufacturer** must add a certificate that item(s) is manufactured by them as per range of products given in the list of requirement Price Bid Format (PART III).
- **3.3** Authorized agents must add authorisation letter from their Manufacturer / Principals on the letter head of the manufacturer / principals. The authorization letter must give / mention the purpose for which it is allowed. The validity period of the authorization letter shall be for the entire contract period and extensions if any, otherwise tender will be liable for rejection.
- **3.4** In case both manufactures and authorized agents participate in tender, the offer of the manufacturer only shall be considered for evolution and the offer of authorized agent shall be rejected.
- **3.5** Full description & specifications, make / brand and name of the manufacturing firm must be clearly mentioned in the tender failing which the tender will not be considered. The Tenderer must also mention whether the goods are imported / indigenous. Descriptive literature / catalogues must be attached with the tender in original.
- **3.6** Tenderer are required to quote their prices clearly indicating actual cost of item FOR to NMP Hospital, Mangalore. GST should be shown separately. Please quote FOR destination price of each item separately. The price has to be uploaded as described in the Format given at Price Bid format (PART III) in Indian Rupee only.
- **3.7** The Supply order itself binds as agreement for the subject contract for supply of Branded Medicines to Port Authtoiry Hospital.
- **3.8** The Chairman will have full powers to relax any conditions or fix any rate after award of contract to meet any contingencies or hardship for reasons to be recorded in writing.
- **3.9** All medicines ordered shall be delivered within 30 days from the date of issuing purchase order. In case of Emergency Purchase all the medicines ordered shall be delivered within 15 days from the date of issuing purchase order. If any defaulted on the above condition, subsequent orders will be placed with the matched supplier or with the next Tenderer at higher rate. The difference of cost will be recovered from the L1 Tenderer. These conditions are incorporated in the work order to ensure timely supply of the drug and there by NMPA cater the needs of the Hospital in time and after assessing the quantity of the drug.
- **3.10** All the aspects of safe delivery of goods shall be the exclusive responsibility of the supplier. The medicines that are to be supplied under this contract shall have minimum remaining life of One year as on date of receipt of the medicines by the main medical store, NMPA.

- **3.11** If the selected Agency / Firm fails to deliver the drugs / consumables items or replace the defected / spurious / expired / soon to expire items within the stipulated date & time, a penalty on weekly basis for delay @ 0.5% of total order value per week, subject to maximum of 10% of total order value + applicable GST as penalty.
- 3.12 The Specification and quantity of the item needed are mentioned in Price Bid Format (PART III), but it is approximate detail and is subject to increase/decrease at the discretion of the competent authority of NMPA, Mangalore. The payment would be made for actual supply taken and no claim in this regard shall be entertained.
- **3.13** Where the specifications are as per Tenderers range of product & Tenderers offer should mention that the item meets all specifications as per the tender enquiry and if there are improvements / deviations the same should be brought out on separate Letter Head of the firm. It would be at the discretion of the competent authority of the NMPA, Mangalore to accept or reject such deviations which are not in accordance with our required specifications as per Price Bid Format (PART III).

3.14 FALL CLAUSE

- 3.14.1 If, at any time, during the said period, the supplier reduces the said prices of such Drugs / Consumables or sells such Drugs / Consumables to any other person / organization / Institution at a price lower than the chargeable, he shall forthwith notify such reduction or sale to the Chief Medical officer, NMPA, Mangalore and the price payable for the Drugs / Consumables supplied after the date of coming into force of such reduction or sale shall stand correspondingly reduced.
- 3.14.2 The supplier shall furnish the following certificate to the Chief Medical Officer along with each bill for payment of supplies made against Rate Contract Tender. "I / We certify that the Drugs / Consumables of description identical to the Drugs / Consumables supplied to the NMPA under the contract against Tender herein have not been offered / sold by me / us to any other person / organization / Institution up to date of bill / the date of completion of supplies against all supply orders placed during the currency of the tender / rate contract at the price lower than the institute under contract / against tender".
- 3.14.3 After Price bid the contract shall be awarded to the Manufaturer/Dealer/ Distributor fulfilling all the conditions and who has quoted the lowest rate as per financial bid after complying with all the Acts / provisions stated / referred to for adherence in the tender
- 3.14.4 The registered office / distributor of the manufacturer / company preferably in the City of Mangalore and a responsible person should be available on call on all working days between 9.00 am to 5.00 pm. The contact details along with the mobile number of the person should be provided.

3.15 FORCE MAJEURE:

Any failure or omission to carry out the provisions of this supply by the supplier shall not give rise to any claim by supplier and purchaser one against the other, if such failure or omission arise from an act of God which shall include all acts of natural calamities from civil strikes compliance with any status and or requisitions of the Government lockout and strikes, riots, embargoes or from any political or other reasons beyond the supplier's control including war (whether declared or not) civil war or state of incarceration provided that notice of the occurrence of any event by either party to the other shall be within two weeks from the date of occurrence of such an event which could be attributed to force majeure.

3.16 <u>COURT SUITS:</u>

No suits or any proceeding in regard to any matter arising in any respect under this contract shall be instituted in any court save in the city civil courts of Mangalore. It is agreed to that no other court shall have jurisdiction to entertain any suit or proceedings, even though part of the cause of action might arise within their jurisdiction.

3.17 <u>TERMINATION OF THE CONTRACT</u>

- 3.17.1 In the event of repeated instances of unsatisfactory service or any failure at any time on the part of the contractor to comply with the terms and provisions of this contract to the satisfaction of NMPA (who shall be the sole judge and whose decision shall be final, it shall also be open to NMPA to terminate this contract by giving not less than Ninety (90)days notice in writing to that effect and if the contractor, does not make good his default within the notice period, NMPA shall be entitled to terminate the contract as a whole or in part.
- 3.17.2 In the event of such termination of the contract, NMPA shall be entitled to: forfeit the Performance Guarantee as it may consider fit; get the balance/remaining work done by making alternative arrangements as deemed necessary and until such time NMPA is able to appoint a new regular Contractor; and recover from the contractor (appointed under this tender) any extra expenditure incurred by NMPA in getting the work done and damages which NMPA may sustain as a consequence of such action.
- 3.17.3 If the extra expenditure incurred by NMPA on account of unsatisfactory performance of the contractor as mentioned in paragraphs above is more than the Performance Security proposed to be forfeited, the expenditure over and in excess of the Performance Security may be recovered by deducting the said amount from pending bills of the contractor under this tender or from money due to the contractor by NMPA under this or any other contract or otherwise. The contractor shall have no claim whatsoever against NMPA, in consequence on such recoveries or termination of the contract, as stated above.

- 3.17.4 if at any time the contractor becomes insolvent or files an application for insolvency or any creditor of his moves the court for adjudicating him as an insolvent or, if he is convicted by any court of law, withdraws from the contract, NMPA will have the absolute option of terminating the contract forthwith and he shall have no right for damages or compensations on this account.
- 3.17.5 Further, NMPA reserves the right to terminate/pre-close the contract at its convenience, without assigning reasons to the contractor by giving a notice period of Thirty (30) days. The contractor shall not have right of any claim on NMPA on account of such termination.

3.18 DEBARRING OF BUSINESS DEALINGS

In the following cases, firms or individuals shall be debarred for a period of three (3) years, from participating in the tenders to be floated with intimation to MSME if applicable.

- In the event of the L1 bidder not starting the supply of medicines as per the work order within the stipulated time.
- 2) In the event of premature termination of contract in terms of provisions of clause 3.18 above.
- 3) NMPA shall also be entitled to debar the contractor for participation in future tenders of NMPA. Further, in case if it comes to the notice of NMPA that the bidder/contractor has used forged documents or misrepresented the facts in any manner either to get the contract or during the pendency of the contract, in all such cases NMPA at its sole discretion may terminate the contract and debar such contractor
- 4) If a firm submits fraudulent, un-encashable Financial Instruments stipulated under the Tender and Contractual conditions.
- 5) If a firm violates the Code of Ethics mentioned above and directly or through an agent, engages in corrupt, fraudulent, collusive or coercive practices in procurement or execution of Contract.
- 6) If makes fraudulent attempts to pass off or mis-declare inferior goods or short quantities.
- 7) If violation of Fall Clause by Rate Contract holding Firms.
- If attempts to influence NMPA's decisions on scrutiny, comparison, evaluation and award of Tender.

On account of doubtful loyalty to the country or national security consideration as determined by appropriate agencies of the Govt. of India. (Normally such banning would be initiated by the Central Govt./ Ministry) Names of Banned firms will be widely shared and put on the Website, to prevent inadvertent business dealings by any unit of Port. An order for banning passed for 3 years shall be deemed to have been automatically revoked on the expiry of that specified period and it will not be necessary to issue a specific formal order of revocation, except that an order of banning passed on account of doubtful

loyalty to the country or national security consideration shall continue to remain in force until it is specifically revoked.

4.0 SCOPE OF THE SUPPLY

After 30 days of the letter for replacement of the stock, if the stocks are not replaced by the supplier and lying in the Main Medical store and allowed them till the date of expiry of drugs, the value of the quantity of stock expired will be recovered from their future bills.
- **4.4** In case the supplies are found defective at any stage these medicines shall immediately be taken back by the supplier and will be replaced without any delay. Else liquidated damages shall be charged.
- 4.5 In case the Tenderer on whom the supply order has been placed, fails to make supplies within the delivery schedule and the purchaser has to resort risk purchase, the purchaser (NMPA, Mangalore) may recover from the Tenderer the difference between the cost calculated on the basis of risk purchase price and that calculated on the basis of rates quoted by Tenderer. In case of repeated failure in supplying, the ordered medicines, the supply order will be cancelled and performance security deposit will be

4.6 **PAYMENT TERM:**

- 4.6.1 On successful supply of the ordered items, the supplier shall submit the Bill in triplicate along with following documents:-
 - 4.6.1.1 Packing List with batch numbers with clear mentioning of product life span (i.e.Date of production and Date of Expiry).
 - 4.6.1.2 Firms should enclose drug analysis report for each batch of medicines, while supplying.
- 4.6.2 On receipt of Bill along with above documents, the SMO in charge of Main Medical store shall verify the supplied items along with the Bill details and forward to the Main Medical Store.
- 4.6.3 The Main Medical store shall account for the receipt and issue of requested items in Main Medical store Ledger and record pass order and transmit the same onward for payment within a reasonable time of 15 working days.

- 4.6.4 Applicable Taxes will be deducted from the Bills of the Bidders as per Govt in force.
- 4.6.5 The purchase orders will be placed as and when required.
- 4.6.6 Payment for the supply of medicines for the distributor shall be made as per the instructions of the Manufacturer (successful bidder).
