1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 2. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

- 1. **APPLICABLE:** CPSE OMC's are eligible to participate in the biddi ng process
- 2. UNIT OF MEASURE: unit of measures in KL. The rate offered sh ould be in Rupees per KL, inclusive of all components, on FOR dest ination basis at NMPA wharf Area.

3. PRICE BID:

- **4. EVALUATION OF BID:** L1 bidder will be selected from Gem pric e Bid.
- 5. PURCHASE ORDER: GeM contract Order will be placed on the s uccessful bidder. As and when LSHF HSD is required, Purchase Or der/Purchase Intimation through e-mail will be placed on L1 bidde r in consignmentS, based on requirement of NMPA. Depot price (in clusive of Excise Duty + additional Excise Duty + Delivery charge s/freight and Green Cess + VAT) ruling as on date of delivery will be considered for such PO. Discount (in INR) offered by the L1 Bid der in the Additional Financial Document will be applied on the de pot price for each Purchase Order/Consignment.
- **6. VALIDITY:** The contract will be valid for a period one year from t he date of acceptance of the offer.
- 7. END USER: Marine department of NMPA is the end user of LFHF HSD. All communication regard, price variation, Invoicing, deliver y, payment etc. shall be made with Sr. Deputy Marine Engineer vi de e-mail Id <u>me-section@nmpt.gov.in</u>.
- 8. DELIVERY OF EACH CONSIGNMENT: Consignment shall be de livered within 72Hrs on receipt of PO/Intimation.

- **9. FAILURE TO DELIVER WITHIN 72 Hrs:** if the supplier fails to d eliver the consignment within 72 Hrs of placing the order for two o ccasions during the contract period, NMPA reserves the right to ca ncel the contract with a notice period of 7 days.
- **10. PAYMENT:** 100% advance payment shall be made before deliv ery. However payment by Cheque to be accepted by the successf ul bidder in case of emergencies caused due to technical/ Internet problems.
- **11. TEST REPORT**: The Oil Company shall submit a valid Test Report & e-Bunker Delivery Note along with the each consignments.
- 12. Bills duplicate shall be raised weekly against the fuel drawing Off icers of NMPA and forwarded to respective division/department, m entioning date & time of fuel drawn, along with quantity, rate of fu el supplied and discount.
- 13. Any change in rates LSHF-HSD due to changes in statutory duties , levies/taxes by union Govt./State Govt./Local body must be intim ated, supported by certified copy of such notification to <u>me-sectio</u> <u>n@nmpt.gov.in</u>
- 14. Copy of PAN card, copy of GST Registration certificate shall be en closed along with the offer. The firm must furnish Bank informatio n for E-Payment with the following details. Name and Full address of the Tenderer, Credit Account No, Account type(SB or CA or OD), Name of the Bank, Branch, MICR Telephone/Mobile/Fax No. of the tenderer, Xerox copy of a cancelled cheque should be enclosed, P AN(Xerox copy of Permanent Account Number shall be enclosed)

- **15.** Prior intimation will be given through email for requirement of th e fuel.
- **16.** The competent authority of New Mangalore Port Authority reserv es the right to accept or to reject any or all offers in part or full.
- 17. In the event of continued unsatisfactory performance or non-com pliance with any of the provisions of this contract, NMPA reserves the right to cancel the contract by giving 30 days' notice and deb ar from participation in future tenders at NMPA for a period of 02 y ears.
- **18.** Further, NMPA reserves the right to terminate/pre-close the contr act at its convenience, without assigning reasons to the contractor by giving a notice period of 30 days. The contractor shall not hav e right of any claim on NMPA on account of such termination.
- 19. Any damages to the fuel delivery vehicle or any other vehicle or persons due to any accident or due to any other reasons during th e period of contract will be at Contractors risk and cost. The Port Authority shall not be responsible for the same in any manner. Su ccessful contractor shall submit an undertaking indemnifying NMP A as per Annexure I.
- **20.** Income tax as applicable will be deducted at source.
- **21. Split of Order:** NMPA reserve the right to split the total quantity of LSHF HSD among bidders as per GeM standard Terms and Con ditions.

- **22.** The firm must ensure necessary safety measures during delivery of consignments.
- **23.** The contractor shall be responsible to comply with all requiremen ts of various labour, commercial law/rules, all statutory requireme nts necessary for the contract any acts/rules applicable to this con tract.
- 24. NMPA will award the contract to the bidder whose bid has been d etermined to be responsive to the bidding documents and who ha s offered the lowest prices. Discount percentage offered in AFD on depot price of the L1 Bidder on government notified rate shall rem ain firm and fixed during the entire period of contract. If more tha n one bidder is L1 for a particular category or item, then the work/ Contract order shall be issued as per GeM T&C.
- **25.** The discount offered shall be valid during the contract period of T welve months from date of award of contract.
- **26. Price Variation Clause:** Bidder to quote the total price on GeM Portal, including all applicable taxes and other charges for deliver y at NMPA, after applying the discount offered by the bidder.

During execution/currency/tenure of the contract, prevail ing depot price of LSHF HSD as on the date of supply after conside ring of discount shall be applicable. Successful bidder has to subm it the documentary proof of prevailing depot price along with invoi ces in support depot price for each consignments of LSGF HSD on the date of supply.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
