4. The bike shall be delivered within 10 days from the date of payment.
5. Tender evaluation shall be done on the basis of **lowest value (L1)** quoted. The complimentary items and GST element if any will **not be considered** for comparison.
6. Upon placing the purchase order, the agency shall provide the Proforma invoice to enable NMPA to release 100% payment. Upon receipt of payment by the agency and against delivery, the agency shall provide the GST invoice.
7. Income tax as applicable will be deducted at source.
8. The bid with any counter conditions will be summarily rejected.
9.
