The I-POS application includes provisions for uploading all necessary documents related to the import and export processes such as import application, export application, agent authorization, commercial invoice, BL, packing list and copy of custom documents & ullage records. All port users are hereby instructed to utilize this online facility for submission of the above-said documents.
