- 5. The quotation must be submitted as per the format furnished by the Port Authority.
- 6. The Port Authority reserves the right to recover any Loss sustained due to any delayed delivery by the way of penalty.
- 7. The New Mangalore Port Authority reserves the right to accept the offer by individual items and reject any or all tenders without assigning any reason thereof and does not bind itself to accept lowest quotations.
- 8. The offered price in BOQ Sl. no. 1 should include To and Fro Transportation charges and any other charges excluding GST.
- 9. The HSN code/SAC code (as applicable) of the individual items is to be mentioned.
- 10. The price quoted should be net and valid for a minimum period of three months from the date opening of quotations.
- 11. The Budgetary quotation should be free from corrections /erasures. In case there are any unavoidable corrections it should be properly attested. If not the quotation will not be considered.
- 12. After proper maintenance / service, the firm should submit proper Inspection and Fitness Certificate of Life Jackets and Work done Report with validity of one year.
- 13. 10% of total annual contract value plus applicable GST to be submitted as a security deposit for Performance Guarantee, which will be released after successful completion of contract and on receipt of firms request letter. If the maintenance/service is not up to the satisfaction of user department the entire amount retained Security Deposit will be forfeited.
- 14. The material supplied will be inspected by NMPA at the time of delivery after maintenance/service, if any defects found, NMPA reserves the right to seek the remaintenance of the life jacket within 5 days at the firms own risk, cost and transportation.
- 15. In case any of the information by the firm is found to be wrong / false during scrutiny of quotation, it shall be disqualified and rejected.
