
Scope of work:-

1. Develop web and mobile application compatible with Android and IOS mobile platform to collect the following details of the NMPA beneficiaries to create Medical Identification cards:-
 - a. Beneficiary
 - i. Name of the beneficiary
 - ii. Whether employee /retiree /RCHW /Retired RCHW / Family pensioner / CISF
 - iii. Employee No
 - iv. Designation (this should be filled only in case of employees and not retirees)
 - v. Department currently working :
 - vi. Class of the employee (in case of retirees class at the time of retiring)
 - vii. DOB
 - viii. Adhaar No
 - ix. Photocopy of the adhaar (User shall be able to attach the copy of adhaar here or click the picture of adhaar and upload)
 - x. Photo
 - xi. Address with D No, Street, Locality, Town, City, District, State and Pin code.

- xii. Mobile/phone No
- xiii. Blood group
- b. Dependent (Provision for up to five 10 entries)
 - i. Name of the Dependents availing Medical benefits
 - ii. Relation with the dependent.
 - iii. DOB
 - iv. Adhaar No
 - v. Photocopy of the adhaar (User shall be able to attach the copy of adhaar here or click the picture of adhaar and upload)
 - vi. Photo
 - vii. Address with D No, Street, Locality, Town, City, District, State and Pin code.
 - viii. Mobile /Phone No
 - ix. Blood Group
- 2. The application shall be designed such that, it can be downloaded from the play store (Android phones) and Apple stores (IPhone) and can be installed by the beneficiary and dependents easily without any hassles.
- 3. The application shall be user friendly such that the beneficiaries/dependents can easily upload the requested details sought above. The beneficiaries/dependents shall be able to click their pics/selfies and shall upload the same easily onto the application without any issues.
- 4. NMPA should be able to generate a report of the details of the beneficiaries/dependents after the completion of the process from the application, preferably in excel, which can be utilized for creating a Medical Identification number by NMPA or its appointed agencies.
- 5. The application shall be free from bugs and super secure.
- 6. Under security stipulations, hospital apps should rely on multifactor (preferably biometric) authentication and authorization techniques to prevent leakage of sensitive personal data.
- 7. The users should be able to upload files from third parties (for instance, social media, Electronic Health Records systems or Digilockers)

Terms and Conditions:

1. The Tenders should carry out the work within two months from the date of issue of work order/ LOA.
2. The approximate number of beneficiaries is around 6000. The numbers may vary slightly depending on retirement / Transfers etc. of employees/CISF personal.
