**Sub:** Fixed berthing window policy for container vessels at B. No. 14.-Reg.

**Ref:** 1. TN No. 1/2/2019-20/DTM(O/R), Dated 30.11.2023

In accordance with the aforementioned Trade Notice, a fixed window policy has been framed and successfully put into place for Berth No. 14 as of September 30, 2022, to facilitate assured services to the EXIM trade, Mainline/Feeder line Operators, Terminal Operator, and Port Authority.

The fixed berthing widow has been updated (Clause No.8) under the provisions of Clause No.8 Note (iv), in light of various requests from the Lines concerning new window, manifest boxes to Port, in consultation with the Liners and the PPP Operator.

The revisions are as follows:
